**In the matter of tariff(s) for Aeronautical Services in respect of IGI Airport, New Delhi – w.e.f. 01.04.2014.**

The Authority had, vide Order No. 03/2012-13 dated 24.04.2012, approved the aeronautical tariff(s) for IGI Airport, New Delhi, for the first control period w.e.f. 01.04.2009 to 31.03.2014.

2. The Authority had, vide its letter dated 10.09.2013, informed Delhi International Airport Ltd. (DIAL) to file their tariff proposal for the second control period starting w.e.f. 01.04.2014.

3. DIAL has, vide submission dated 10.11.2013, filed its tariff proposal for the second control period starting w.e.f. 01.04.2014. The said proposal is under consideration of this Authority

4. DIAL has further requested that since, the determination of tariff for the second control period may take some time, the Authority may allow continuation of the existing rates initially for a period of six months i.e. till 30<sup>th</sup> September 2014 DIAL has also stated that the amount collected by DIAL during this period may be adjusted from their entitlement for the second control period.

5. The Authority understands that the tariff determination exercise, including the discussion/ deliberations of the Authority on the airport operator's submission; issue of a Consultation Paper containing the proposals of the Operator and the Authority's position; Holding Stakeholder Consultation meeting and considering the stakeholders responses and issue of final tariff order, may usually take about 4 to 6 months.



6. In view of the above and in order to avoid any regulatory vacuum in respect of the tariffs being levied at IGI Airport, New Delhi the Authority hereby orders that:-

- (i) Aeronautical tariff(s) approved by the Authority vide Order No. 03/2012-13 dated 24.04.2012 shall continue for a further period of two months w.e.f. 01.04.2014, i.e. upto 31.05.2014 or until further orders, whichever is earlier.
- (ii) The revenue so collected by the airport operator (DIAL) during such period shall be adjusted from the Aggregate Revenue Requirement for the Second control period starting w.e.f. 01.04.2014.
