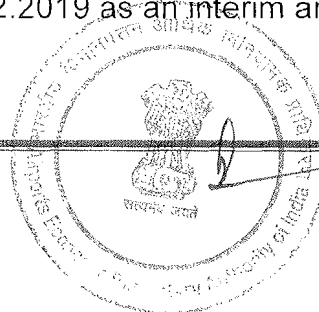

**In the matter of Economic Regulation of aeronautical services provided by Independent Service Providers of Cargo Facility, Ground Handling and Supply of Fuel to the Aircraft – Interim arrangement to continue the levy of existing tariff beyond 31.03.2019 for the First/second control Period (as applicable).**

This is regarding interim arrangement for levy of existing tariff beyond 31.03.2019 for the First/Second Control Period (as applicable) in respect of the Independent Service Providers (ISPs) as mentioned below:

1.	M/s Indo Thai Airport Management Services Pvt. Ltd. (second control period, 01.04.2016 to 31.03.2021)	Ground Handling Service	Jaipur, Lucknow
2.	M/s Bhadra International (I) Limited (second control period 01.04.2016 to 31.03.2021)	Ground Handling Service	Kolkata, Chennai, Trivandrum, Calicut
3.	M/s BPCL-KIAL Fuel Farm Limited (First control period, 01.04.2018 to 31.03.2023)	Fuel Farm Service	Kannur

2. Airports Authority of India (AAI) has informed that the last date of notice period for termination of the ground handling contracts to M/s Indo Thai Airport Management Services Private Limited at Jaipur, Lucknow Airport and to M/s Bhadra International (I) Limited at Kolkata, Chennai, Trivandrum and Calicut Airport, has been extended from 30.06.2019 to 31.12.2019 as AAI's tender action to appoint new ground handling agencies, is under process. Hence these ISPs may be allowed to continue levy of existing tariff(s) as on 30.06.2019 in respect the Airports as mentioned above upto 31.12.2019 as an interim arrangement.



4. M/s BPCL-KIAL Fuel Farm Limited (BKFFPL) at Kannur Airport has submitted its MYTP/ATP to the Authority for the First Control Period which is under process and will take some more time for determination of tariff. Hence M/s BKFFPL may be allowed to continue levy of the existing tariff as on 30.06.2019 upto 30.09.2019 or till the date of determination of tariff by AERA whichever is earlier.

### ORDER

In view of the above, to avoid any regulatory vacuum in respect of the tariff(s) being levied by the regulated entities, the Authority, in exercise of powers conferred by Section 13(1) of the Airport Economic Regulatory Authority of India Act, 2008 hereby orders that:-

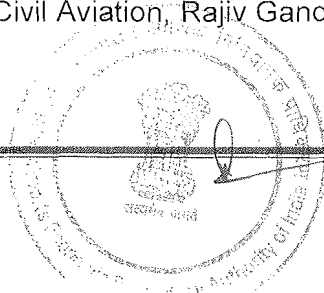
- (i) M/s Indo Thai Airport Management Services Private Limited is allowed to continue the levy of existing tariff(s) as on 30.06.2019 for rendering ground handling services at Jaipur and Lucknow Airports upto **31.12.2019**. Further, AAI will intimate the status of appointing new Ground Handling Agencies and also ensure the timely submission of proposal by the newly appointed Agency to the Authority.
- (ii) M/s Bhadra International (I) Limited is allowed to continue levy of existing tariff(s) as on 30.06.2019 for rendering ground handling services at Kolkata, Chennai, Trivandrum and Calicut Airports upto **31.12.2019**. Further, AAI will intimate the status of appointing new Ground Handling Agencies and also ensure the timely submission of proposal by the newly appointed Agency to the Authority.
- (iii) M/s BPCL-KIAL Fuel Farm Limited is allowed to continue levy of existing tariff as on 30.06.2019 upto **30.09.2019** or till the date of determination of tariff by AERA whichever is earlier.
- (iv) The Airport Operators may ensure compliance of the Order.
