Subject: - Consultation Paper No. 05/2014-15 dated 12.06.2014 – Reg

Attention of all concerned is invited to Consultation Paper No. 05/2014-15 dated 12.06.2014, issued by the Authority "In the matter of Normative Approach to Building Blocks in Economic Regulation of Major Airports" vide which the Authority had sought comments from the stakeholders. The last date for submission of comments was 07.07.2014.

2. The Government of Karnataka (GoK), Federation of Indian Airlines, Associated Chambers of Commerce and Industry of India (ASSOCAHAM) and various Stakeholders during the Stakeholder Consultation Meeting held on 26.06.2014, requested for extension of time for submission of comments. The requests made by the stakeholders were considered by the Authority and it was decided that the last date for submission of comments on Consultation Paper No. 05/2014-15 dated 12.06.2014 be extended upto 08.09.2014. The same was uploaded vide Public Notice No. 04/2014-15 dated 04.07.2014.

3. Association of Private Airport Operators (APAO) vide letter no APAO/AERA/2014-15 dated 11.08.2014 again requested the Authority to provide a further extension of one more month for submission of comments stating that there was an inordinate delay in identifying and appointing a suitable consultant for them.

4. The request made by APAO was considered by the Authority and it was decided that the last date for submission of comments on Consultation Paper No. 05/2014-15 dated 12.06.2014 be further extended upto 09.10.2014. Accordingly, Public Notice No. 08/2014-15 dated 01.09.2014 was issued.

5. The Authority has further received requests from Confederation of Indian Industry, (CII), Delhi International Airport Ltd, Mumbai International Airport Ltd, Hyderabad International Airport Ltd, Bangalore International Airport Ltd and Association of Private Airport Operators for extending the timeline for submission of comments. While DIAL, HIAL, BIAL and APAO have sought additional time of one month for submission of comments, CII has sought time upto 30.11.2014 and MIAL has sought time upto 31.12.2014. The stakeholders have stated that the matter is crucial, requiring comprehensive assessment on various aspects at Domestic and International platform.

6. The request made by the above stakeholders has been considered by the Authority and in view of the specific request for extension it has been decided that the last date for submission of comments on Consultation Paper No. 05/2014-15 dated 12.06.2014 be further extended up to **07.11.2014**. The Authority categorically decided that no further extension of time would be permitted.
