Subject:- Consultation Paper No. 9/2013-14 dated 21.05.2013 regarding determination of Aeronautical Tariffs in respect of Rajiv Gandhi International Airport, Shamshabad, Hyderabad for the first control period (01.04.2011 – 31.03.2016) – Extension of time - Reg.

Attention of all concerned is invited to Consultation Paper No. 9/2013-14 dated 21.05.2013, issued by the Authority in the matter of "Determination of Aeronautical Tariffs" in respect of Rajiv Gandhi International Airport, Shamshabad, Hyderabad for the first control period (01.04.2011 -31.03.2016) vide which the Authority had sought comments from the stakeholders. The last date of submission of comments was 01.07.2013.

2. Subsequently, based on request from Government of Andhra Pradesh (GoAP), Federation of Indian Airlines (FIA) and various stakeholders during the Stakeholders' Consultation meeting held on 18.06.2013, the last date for submission of comments was extended upto 22.07.2013 vide Public Notice No. 01/2013-14 dated 24.06.2013.

3. Further, in view of request received from GoAP, vide letter dated 17.07.2013, requesting for two more weeks to furnish comments, the last date for submission of comments on the proposals contained in Consultation Paper No. 9/13-14 was further extended upto 05.08.2013, vide Public Notice No. 03/2013-14 dated 22.07.2013.

4. Thereafter, the Ministry of Civil Aviation (MoCA) vide letter dated 02.08.2013 had requested for extension of time upto 02.09.2013. The request was considered by the Authority and the last date of submission of comments on Consultation Paper No. 9/13-14 was extended upto 02.09.2013 vide Public Notice No. 05/2013-14 dated 05.08.2013.

5. Thereafter, in view of letter dated 02.09.2013 from GoAP and letter dated 02.09.2013 from MoCA, requesting for further extension of time to furnish comments, the last date of submission of comments on Consultation Paper No. 9/2013-14 was extended upto 16.09.2013, vide Public Notice No. 9/2013-14 dated 11.09.2013.


6. The Authority has, now, received letter no. AV.20036/14/2013-AD dated 16.09.2013 (**Annexure I**) from MoCA, stating that they are "in the process of

examination of the Consultation Paper No. 9/2013-14 on 21.05.2013 for which the comments of Govt. of Andhra Pradesh, who is also a stakeholder, are still awaited". In this letter MoCA has requested for extension of time upto 01.11.2013 for furnishing its comments on the said Consultation Paper No. 9/2013-14.

7. Now, after careful consideration of the requests received from Ministry of Civil Aviation, for extension of the last date for submission of comments on Consultation Paper No. 9/2013-14 dated 21.05.2013, the Authority has decided to extend this date upto 01.11.2013.

8. In view of the above, all the stakeholders are requested to submit their comments / views on the proposals contained in the Consultation Paper No. 9/13-14 dated 21.05.2013 latest by 01.11.2013.
