In the matter of ad hoc Tariff for Ground Handling Services to be provided by the SPV M/s Bird Airport Services (Mohali) Private Limited at Chandigarh International Airport, Mohali, for the period from 19.07.2021 to 31.12.2021.

M/s Globe Ground India Pvt. Ltd. is selected for providing Ground Handling services at Chandigarh International Airport, Mohali, Punjab through an RFP selection process by Chandigarh International Airport Ltd. (Airport Operator) for a period of 10 years, from the commercial operation date. In accordance with the requirements of the RFP, M/s Globe Ground India Pvt. Ltd. has to form a Special Purpose Vehicle (SPV). Accordingly, a SPV named M/s Bird Airport Services (Mohali) Private Limited has been incorporated on 30.03.2021.

2. The SPV, M/s Bird Airport Services (Mohali) Private Limited has approached the Authority for approval of ad hoc tariff for their GH services at Chandigarh International Airport during the interim period till the time their regular tariff is determined. A copy of the requisite security clearance vide BCAS letter dated 14.07.2021 valid for a period of 5 years has been submitted in this regard.

3. M/s Bird Airport Services (Mohali) Private Limited has informed the Authority that they are in the process of preparation of MYTP for 3rd Control Period (FY 2021-22 to FY 2025-26) and ATP for FY 2021-22 & FY 2022-23 and shall submit the same shortly. The Authority notes that as per the Letter of Intent to Award (LIOA) dated 09.03.2021 issued by CHIAL, on the date of receipt of requisite BCAS security clearance by the SPV, the LIOA shall be deemed as the Letter of Award (LoA).

4. The Authority having examined the request, has decided to allow M/s Bird Airport Services (Mohali) Private Limited to levy the existing tariff as approved for the other Ground Handling Service Provider at CHIAL, namely Air India Airport Services Ltd. (erstwhile AIATSL- ref. Order no.23/2019-20 dtd: 14.02.2020 & Interim Order no.67/2020-21 dtd: 25.03.2021), on ad hoc basis, w.e.f. 19.07.2021 to 31.12.2021, or, determination of regular Ground Handling tariff, whichever is earlier.




ORDER

5. Upon careful consideration of the material available on records, the Authority, in exercise of powers conferred by Section 13(1) of the Airport Economic Regulatory Authority of India Act, 2008 hereby orders that:

- (i) M/s Bird Airport Services (Mohali) Private Limited is allowed to levy and collect, on ad hoc basis, the existing tariff for Ground Handling Services at Chandigarh International Airport, as approved for the other Ground Handling Service Provider at Chandigarh International Airport, Mohali, Punjab, namely Air India Airport Services Ltd. (erstwhile AIATSL) as per attached tariff card at **Annexure- I**, w.e.f. 19.07.2021 to 31.12.2021, or, determination of regular Ground Handling tariff for 3rd Control Period, whichever is earlier.
- (ii) The tariff charged by M/s Bird Airport Services (Mohali) Private Limited for Non-Schedule Operations should not exceed the tariff approved by AERA for Scheduled Operations for 'similar class of aircraft.'
- (iii) Tariff approved as above will be the maximum tariff to be charged from the users of the Ground Handling service. No other charges to be levied over and above the approved tariff.
- (iv) M/s Bird Airport Services (Mohali) Private Limited is advised to file the MYTP for 3rd Control Period (FY 2021-22 to FY 2025-26) at the earliest.
- (v) The Airport Operator shall ensure compliance of the Order.
