In the matter of ad hoc Tariff for Ground Handling Services to be provided by the SPV M/s GSEC Bird Airport Services Pvt. Ltd, for the period from 18.11.2021 to 31.03.2022.

The consortium led by Bird Wide (I) Flight Services Pvt. Ltd. (BWFS) is selected for providing Ground Handling services at Mangaluru International Airport, Mangaluru, Karnataka through an RFP selection process by Adani Mangaluru International Airport Ltd. (Airport Operator) for a period of 05 years (extendable by another 05 years), from the Commercial Operation Date. In accordance with the requirements of the RFP, M/s BWFS had to form a Special Purpose Vehicle (SPV). Accordingly, a SPV named M/s GSEC Bird Airport Services Pvt. Ltd. has been incorporated on 20.03.2021.

2. In this regard, the SPV, M/s GSEC Bird Airport Services Pvt. Ltd. vide letter dated 26.10.2021 has approached the Authority for allowing the same tariff as approved for the other Ground Handling Service Provider at Mangaluru Airport namely Bhadra International (I) Pvt. Ltd., on ad hoc basis, during the interim period for their GH Services at Mangaluru International Airport, till the time their regular tariff is determined. Airport Operator AMIAL has confirmed (via mail dated 09.11.2021) the preparedness of the SPV for commencement of GH services from 11.11.2021.

3. M/s GSEC Bird Airport Services Pvt. Ltd., has informed the Authority that they are in the process of preparation of MYTP for the 1st Control Period (FY 2021-22 to FY 2025-26) and shall submit the same shortly. The Authority notes that as per the Letter of Intent to Award (LOIA) dated 08.03.2021 issued by AMIAL, on the date of receipt of requisite BCAS security clearance by the SPV, the LOIA shall be deemed as the Letter of Award (LoA). A copy of the security clearance issued vide BCAS letter dated 09.08.2021, valid for a period of 5 years, has also been submitted in this regard

4. The Authority having examined the request, has decided to allow M/s GSEC Bird Airport Services Pvt. Ltd. to levy the existing tariff as approved for the other Ground Handling Service Provider at Mangaluru Airport namely M/s Bhadra International (I) Pvt. Ltd. (ref. Order no. 04/2020-21 dtd: 13.05.2020) on ad hoc basis,



w.e.f. 18.11.2021 to 31.03.2022, or, till the determination of regular Ground Handling tariff for the 1st Control Period, whichever is earlier.

ORDER

5. Upon careful consideration of the material available on records, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airport Economic Regulatory Authority of India Act, 2008 hereby orders that:

- (i) M/s GSEC Bird Airport Services Pvt. Ltd., is allowed to levy and collect, on ad hoc basis, the existing tariff for Ground Handling Services at Mangaluru International Airport, Mangaluru, as approved for the other Ground Handling Service Provider namely M/s Bhadra International (I) Pvt. Ltd as per attached tariff card at **Annexure-I**, w.e.f. 18.11.2021 to 31.03.2022, or, till the determination of regular Ground Handling tariff for the 1st Control Period, whichever is earlier.
- (ii) The tariff charged by M/s GSEC Bird Airport Services Pvt. Ltd. for Non-Schedule Operations should not exceed the tariff approved by AERA for Scheduled Operations for 'similar class of aircraft.'
- (iii) Tariff approved as above will be the maximum tariff to be charged from the users of the Ground Handling service. No other charges to be levied over and above the approved tariff.
- (iv) The Airport Operator shall ensure compliance of the Order.
