**In the matter of determination of ad hoc tariff for Ground Handling Services to be provided by the SPV M/s IndoThai Kolkata Pvt. Ltd., at Netaji Subhas Chandra Bose International Airport, Kolkata, for the period from 01.12.2021 to 31.03.2022.**

M/s IndoThai Airport Management Services Pvt. Ltd., is selected for providing Ground Handling Services at Netaji Subhas Chandra Bose International Airport (NSCBIA), Kolkata, through an RFP selection process by Airport Authority of India (Airport Operator) for a period of 10 years, from the Commercial Operations Date (COD). In accordance with the requirements of the RFP, the selected bidder has to form a Special Purpose Vehicle (SPV). Accordingly, a SPV named M/s IndoThai Kolkata Pvt. Ltd. has been incorporated on 08.02.2021.

2. In this regard, the SPV M/s IndoThai Kolkata Pvt. Ltd. vide their letter dated 01.11.2021 has approached the Authority for allowing the same tariff as approved for the other Ground Handling Service Provider at Kolkata namely Air India Airport Services Ltd. (erstwhile AIATSL), on ad hoc basis, during the interim period for their GH Services (proposed commencement date 01.12.2021) at NSCBIA, Kolkata till the time their regular tariff is determined.

3. M/s IndoThai Kolkata Pvt. Ltd., has informed the Authority that they are in the process of preparation of MYTP for the 3<sup>rd</sup> Control Period (FY 2021-22 to FY 2025-26) and shall submit the same shortly. The Authority notes that as per the Letter of Intent to Award (LOIA) dated 11.01.2021 issued by AAI, on the date of receipt of requisite BCAS security clearance by the SPV, the LOIA shall be deemed as the Letter of Award (LoA). A copy of the security clearance issued by the BCAS vide letter dated 05.07.2021, valid for a period of 5 years, has also been submitted in this regard.

4. The Authority, having examined the request, has decided to allow M/s IndoThai Kolkata Pvt. Ltd., to levy the existing tariff as approved for the other Ground Handling Service Provider at Kolkata Airport namely Air India Airport Services Ltd. (erstwhile AIATSL- ref. Order no. 18/2019-20 dtd: 22.11.2019 and extended further vide Interim Order nos. 67/2020-21 dtd: 25.03.2021 & 18/2021-22 dtd: 15.09.2021), on ad hoc basis, w.e.f. 01.12.2021 to 31.03.2022 or until the determination of regular Ground Handling tariff, whichever is earlier.





## ORDER

5. Upon careful consideration of the material available on records, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airport Economic Regulatory Authority of India Act, 2008 hereby orders that:

- (i) M/s Indo Thai Kolkata Pvt. Ltd. is allowed to levy and collect, on ad hoc basis, the existing tariff for Ground Handling Services at Netaji Subhash Chandra Bose International Airport, Kolkata, as approved for the other Ground Handling Service Provider namely Air India Airport Services Ltd. (erstwhile AIATSL) as per attached tariff card at **Annexure-I**, w.e.f. 01.12.2021 to 31.03.2022, or, till the determination of regular Ground Handling tariff for the 3<sup>rd</sup> Control Period, whichever is earlier.
- (ii) The tariff charged by the SPV M/s Indo Thai Kolkata Pvt. Ltd. for Non-Schedule Operations should not exceed the tariff approved by AERA for Scheduled Operations for 'similar class of aircraft.'
- (iii) Tariff approved as above will be the maximum tariff to be charged from the users of the Ground Handling service. No other charges to be levied over and above the approved tariff.
- (iv) The Airport Operator shall ensure compliance of the Order.
