In the matter of Determination of Ad-hoc Tariff for Ground Handling Services to be provided by M/s IndoThai Amritsar Private Limited at Sri Guru Ram Das Jee International Airport, Amritsar for the period from 22.08.2022 to 31.03.2023.

M/s IndoThai Amritsar Pvt. Ltd. (IAPL) had intimated the Authority vide letter dated 24.09.2021 that M/s IndoThai Airport Management Services Pvt. Ltd. (IAMSPL) had been selected through RFP selection process by Airports Authority of India (AAI) for providing Ground Handling Services at Sri Guru Ram Das Jee International Airport, Amritsar for a period of 10 years from the Commercial Operations Date ("COD"). In accordance of clause 5 of Letter of Intent (LOI) dated 19.02.2021, a special purpose vehicle (SPV) "IAPL" has been incorporated on 24.03.2021.

Subsequently, IAPL vide letter dated 18.05.2022 submitted the copy of following documents and requested the Authority for allowing them to charge the same Tariff, as approved for the other Ground Handling Service Provider at Amritsar Airport, namely, Al Airport Services Limited (earlier known as Air India Airport Services Limited), on ad-hoc basis:



- i. LOI no. AAI/OPS/GHS/12/B1/2020/76 dated 19.02.2021 issued by AAI.
- ii. Certificate of Incorporation of SPV "IndoThai Amritsar Private Limited".
- iii. Security clearance issued by Bureau of Civil Aviation Security.
- 3. Further, M/s IAPL vide letter dated 10.08.2022 submitted copy of Concession Agreement dated 08.08.2022 executed between AAI & IAPL and informed the Authority vide email dated 17.08.2022 that they propose to commence their commercial operations at Amritsar Airport from 22.08.2022.
- 4. The Authority notes that SPV "IAPL" has obtained the security clearance from Bureau of Civil Aviation Security (BCAS), vide BCAS Order dated 12.05.2022, valid for a period of 5 years from the date of issue of security clearance and has executed concession agreement with Airport Operator.
- 5. The Authority, having examined the request of IAPL, feels that submission of MYTP by the ISP for determination of Tariff for Ground Handling Services at Amritsar Airport will take some time. The Authority, in the interim, decides to allow M/s IndoThai Amritsar Pvt. Ltd., to levy the existing Tariff, as approved for the AI Airport Services Limited (AIASL), Amritsar (refer Order no. 23/2019-20 dated 14.02.2020 read with Interim Order nos. 67/2020-21 dated 25.03.2021, 18/2021-22 dated 15.09.2021 & 46/2021-22 dated 17.03.2022), on Ad-hoc basis, from 22.08.2022 to 31.03.2023, or, till the determination of regular Ground Handing Tariff, whichever is earlier.

ORDER

Upon careful consideration of the material available on records, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:

- (i) M/s Indo Thai Amritsar Pvt. Ltd. is allowed to levy, on ad-hoc basis, the existing Tariff for Ground Handling Services, as approved for the other Ground Handling Service Provider, namely, AI Airport Services Ltd. (AIASL) at Sri Guru Ram Das Jee International Airport, Amritsar as per Annexure-I w.e.f. 22.08.2022 to 31.03.2023, or, till the determination of regular Tariff in respect of Ground Handing Services for the First Control Period, whichever is earlier.
- (ii) The Authority decides that Tariff for Domestic Non-Scheduled & General Aviation Operations shall not exceed the approved Tariff for relevant Domestic Scheduled Flights for similar class of aircraft(s).
- (iii) Tariff approved, as above, will be the maximum Tariff to be charged from the Users of the Ground Handling Services. No other charges are to be levied over and above the approved Tariff.
- (iv) M/s IndoThai Amritsar Pvt. Ltd. shall ensure compliance of Standardization of Ground Handling Equipment at Sri Guru Ram Das Jee International Airport, Amritsar, in accordance with the directives issued by Ministry of Civil Aviation vide its letter no. AV-24011/10/2021-AAI-MOCA dated 01.11.2021.



- (v) The Tariff determined herein above is excluding of applicable taxes, if any.
- (vi) The Airport Operator shall ensure compliance of the Order.
