विषय: लखनऊ इंटरनेशनल एयरपोर्ट लिमिटेड द्वारा चौधरी चरण सिंह अंतरराष्ट्रीय हवाईअड्डा (सीसीएसआईए), लखनऊ में प्रदान की जाने वाली एकीकृत ईंधन स्टोरेज और इंटो प्लेन (आईटीपी) सेवाओं के लिए 1.7.2022 से 31.3.2023 तक की अविध के लिए तदर्थ टैरिफ निर्धारित करने के मामले में - मौजूदा टैरिफ (31.03.2023) को आगे 30.09.2023 तक जारी रखने की अंतरिम व्यवस्था।

Sub: In the matter of Order no. 08/2022-23 dated 16.06.2022 regarding ad hoc Tariff for Integrated Fuel Storage and Into Plane (ITP) Services provided at Chaudhary Charan Singh International Airport (CCSIA), Lucknow, by Lucknow International Airport Ltd for the period from 01.07.2022 to 31.03.2023. - Interim arrangement to continue the existing tariff (as on 31.03.2023) up to 30.09.2023.

- This is regarding extension of interim arrangement to levy the existing Tariff (as on 31.03.2023) in respect of Integrated Fuel Storage and Into Plane (ITP) Services being provided by LIAL at CCSIA, Lucknow, for a further period of six months i.e., from 01.04.2023 to 30.09.2023.
- The Authority notes that stakeholders' consultation process, in connection with the determination
  of regular tariff for aeronautical services, including Fuel storage ITP services, for LIAL at
  Lucknow airport is in process and it will take some more time for culmination of Tariff
  determination process including issuance of final Tariff Order.
- 3. Considering the above, as an interim measure, the Authority decides that the LIAL may be allowed to levy the existing tariff (as on 31.03.2023) for Integrated Fuel Storage and Into Plane (ITP) Services for a further period of six (06) months, w.e.f. 01.04.2023 to 30.09.2023, or, till the determination of regular Tariffs for Third Control Period, whichever is earlier.



## **ORDER**

Upon careful consideration of the material available on records, the Authority, in the exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:

- (i) The Lucknow International Airport Limited (LIAL) is allowed to levy and collect the existing Tariff (as on 31.03.2023) for Integrated Fuel Storage and Into Plane (ITP) Services, on an Ad-hoc basis as per Annexure-I, w.e.f. 01.04.2023 to 30.09.2023, or, till the determination of regular Tariff for the Third Control Period, whichever is earlier.
- (ii) Tariff determined, as above, is the maximum Tariff to be charged from the Users and no other charges are to be levied over and above the approved Tariff.
- (iii) The Tariff approved, as above, is excluding of all applicable Govt. taxes, if any.
- (iv) The other terms & conditions of Order no. 08/2022-23 dated 16.06.2022 shall remain unchanged.
