**Sub.: In the matter of levy of Development Fee (DF) for Project Work at Chhatrapati Shivaji Maharaj International Airport, Mumbai – reg.**

1. In compliance of Interim Order dated 19.12.2023 of Hon'ble Telecom Disputes Settlement & Appellate Tribunal on the subject matter, passed in AERA's Appeal No. 4/2023, the period for collection of DF @ Rs. 100/- per domestic embarking passenger and @ Rs. 600/- per international embarking passenger at Chhatrapati Shivaji Maharaj International Airport, Mumbai stood extended till 29.02.2024.
2. Subsequently, in line with Hon'ble TDSAT interim order dated 21.02.2024, 22.03.2024 & 30.04.2024, the period for levy of DF @ Rs. 100/- per domestic embarking passenger and @ Rs. 600/- per international embarking passenger at Chhatrapati Shivaji Maharaj International Airport, Mumbai stood extended till 22.03.2024, 10.05.2024 and 31.07.2024 respectively.
3. The matter came up for hearing before the Hon'ble TDSAT on 24.07.2024, wherein Hon'ble Tribunal directed:
  1. *We have heard the counsels on behalf of respondents – AERA and AAI*
  2. *Counsel appearing for the appellant is seeking time to give reply to the arguments of the respondents.*
  3. *This matter is, therefore, adjourned to 1.8.2024*
  4. *Interim relief granted by this Tribunal vide order dated 19.12.2023 shall stand continued to be operative during the pendency and final hearing of this AERA Appeal.*



4. Accordingly, as the matter is listed for final hearing on 01.08.2024, therefore, in compliance with the direction of Hon'ble Telecom Disputes Settlement & Appellate Tribunal, the period for levy of DF @ Rs. 100/- per domestic embarking passenger and @ Rs. 600/- per international embarking passenger at Chhatrapati Shivaji Maharaj International Airport, Mumbai stands extended till 01.08.2024.
5. All other terms & conditions of AERA Order 09/2023-24 dated 14.06.2023 shall remain unchanged.
