In the matter of Annual Tariff Proposal for the First and Second Tariff Years of the First Control Period submitted by Menzies Bobba Ground Handling Services Pvt Ltd for providing Ground Handling Services at Rajiv Gandhi International Airport, Hyderabad

The Authority had considered the Multi Year Tariff Proposal (MYTP) for the first Control Period (i.e., 2011-12 to 2015-16) submitted by Menzies Bobba Ground Handling Services Pvt (MBGH) for the Ground Handling Services Pvt Ltd for providing Ground Handling Services at Rajiv Gandhi International Airport, Hyderabad, and after due stakeholder consultation, issued Order No. 15/2011-12 dated 13.10.2011 ordering that the ground handling services provided by MBGH is "not material" and tariffs for the same shall be determined under a "light touch approach".

- MBGH submitted their Annual Tariff Proposal (ATP) for the first tariff year (2011-12) and for the second tariff year (2012-13) vide letter no Nil dated 16.03.2012 and 30.03.2012 respectively.
- The Authority considered the submissions made by MBGH and issued a Consultation paper No. 10/2012-13 on 29.06.2012 for considering the ATP for first and second tariff year, with 14 days response time.
- 4. In response, Air Cargo Agents Association of India (ACAAI), vide their email dated 13.07.2012, stated that as the proposal is not related to cargo activities, it does not have any impact on cargo in terms of cost. Further, they have no other comments on the proposal. Thus, said comments are not related to the ground handling activities at RGI Airport, Hyderabad. No comments have been received from any other stakeholder.



ORDER:

- 5. Upon careful consideration of material available on record, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airport Economic Regulatory Authority of India Act, 2008, hereby orders that:
 - (i) The tariff for the Ground Handling Service provided by Menzies Bobba Ground Handling Services Pvt (MBGH) at Rajiv Gandhi International Airport, Hyderabad is determined, for the First Tariff year (2011-12) w.e.f 30.09.2011 as per Annexure—I and for Second Tariff year (2012-13) tariff year, w.e.f. 01.04.2012, as per Annexure—II.
