Subject: In the matter of ground handling services provided by M/s IndoThai Airport Management Services Pvt. Ltd. (ITAMS) at Jaipur and Lucknow Airports – Interim Arrangement for the Second Control Period Commencing 1st April, 2016.

The Authority vide Order No. 01/2016-17 dated 08.04.2016 considered the request of IndoThai Airport Management Services Pvt. Ltd. (ITAMS) for grant of extension of 30 days to submit the tariff proposal in respect of the 2nd Control Period to the Authority and ordered the following:

- (i) *The time line for submitting the tariff proposals by ITAMS to the Authority for 2nd Control Period in respect of Jaipur and Lucknow Airports be extended upto 30.04.2016;*
- (ii) *In the meanwhile ITAMS may resume levy of earlier approved tariff for the ground handling services at the above mentioned airports;*
- (iii) *In case ITAMS fails to submit the tariff proposal by the extended time line of 30.04.2016, their tariff will cease to exist at the above mentioned airports w.e.f. 01.05.2016.*

2. Subsequent to the above, ITAMS has submitted the tariff proposals in respect of ground handling services at Jaipur and Lucknow Airports by the stipulated time line of 30.04.2016 to the Authority.



ORDER

3. In line with the approval accorded by the Authority to all airport operators/ service providers of cargo, ground handling and supply of fuel to aircraft vide Order No. 50/2015-16 dated 31.03.2016 and upon careful consideration of material available on record, the Authority, in exercise of powers conferred by Section 13(1) (a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:

- (i) In order to avoid any regulatory vacuum, IndoThai Airport Management Services Pvt. Ltd. providing ground handling services at Jaipur and Lucknow Airports may continue to charge the tariffs as prevalent on 31.03.2016 for a period of 6 months w.e.f. 01.04.2016 or till determination of tariffs for the second control period whichever is earlier.
