In the matter of Economic Regulation of aeronautical services provided by Airport Operators/Service Providers of Cargo facility, Ground Handling and Supply of Fuel to the aircraft – Interim Arrangement to continue the levy of existing tariffs till determination of tariffs for the Second Control Period.

1. This is regarding interim arrangement for levy of tariffs for the period beyond 31.03.2017 of the second control period(FY.2016-17 to FY. 2020-21) in respect of the Airport Operator(s) and Independent Service Provider(s) mentioned in the table below:

2.1 The Authority vide its Order No. 50/2015-16 dated 31.03.2016, as an interim arrangement, had extended the continuation of the levy of tariffs prevalent on 31.03.2016 for a period of six months w.e.f 01.04.2016 or till determination of tariffs for the second control period, whichever is earlier, in respect of Airport Operators of HIAL, BIAL, CIAL, Airports Authority of India (Major Airports) and Independent Service Providers. The Authority vide its Order No. 05/2016-17 dated 16.05.2016 and Order No. 09/2016-17 dated 23.08.2016 respectively, also allowed M/s Indo Thai and M/s Air India (AIATSL) to continue to charge the tariffs prevalent on 31.03.2016 for a period of six months w.e.f 01.04.2016 or till determination of tariffs for the 2nd control period, whichever is earlier. The Authority vide its Order No. 11/2016-17 dated 29.09.2016 further extended the continuation of levy of tariffs prevalent on 31.03.2016 for a period of six months w.e.f 01.10.2016 or till determination of tariffs for the second control period, whichever is earlier, in respect of Airport Operator(s) and Independent Service Provider(s).

2.2 The Tariffs for the first control period (FY. 2016-17 to FY. 2020-21) in respect of Airport Operator -Chandigarh International Airport Limited has been determined vide AERA Order no. 17/2016-17 dated 27.03.2017 effective from 01.05.2017.

2.3 The Tariffs for the first tariff year (FY.2016-17) of second control period have been determined in respect of the cargo operators- M/s Celebi Delhi Cargo Terminal Management India Private limited (Order No.16/2016-17 dated 14.02.2017) and M/s Menzies Aviation Bobba (Bangalore) Private Limited (Order No.18/2016-17 dated 28.03.2017).



2.4 Kannur International Airport is yet to start their commercial operations. Further, Nagpur International Airport (MIHAN India Limited) also became a major airport in the month of October, 2016 and is levying the tariffs determined by MoCA.

3. The Authority is in the process of scrutinizing the MYTP/ATP submissions received from various Airport Operators and Independent Service Providers viz. Cargo Operators, Ground Handling Agencies and Into Plane Service Providers and the determination process is likely to take another 5-6 months. Hence, the Authority decided that the Airport Operators/Independent Service Providers as listed in para 1 above may be allowed to continue to levy the tariffs existing as on 31.03.2016, for a period of six months w.e.f 01.04.2017 or till determination of tariffs for the second control period, whichever is earlier.

ORDER:-

In view of the above and to avoid any regulatory vacuum in respect of the tariffs being levied by the regulated entities, the Authority, in exercise of powers conferred by Section 13(1) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:

- i. the Airport Operators/Independent Service Providers as per list in para 1 may be allowed to continue levy of the tariffs existing as on 31.03.2016, for a further period of six months w.e.f 01.04.2017 or till determination of tariffs for the second control period, whichever is earlier.
- ii. Chandigarh International Airport may be allowed to continue levy of the existing tariffs from 01.04.2017 to 30.04.2017 as the new tariffs are effective from 01.05.2017.
- iii. Independent Service Provider- M/s Celebi Delhi Cargo Terminal Management India Private limited and M/s Menzies Aviation Bobba (Bangalore) Private Limited may be allowed to continue levy of the tariffs determined by AERA for the first tariff year (FY. 2016-17), for a period of six months w.e.f 01.04.2017 or till determination of tariffs for the second tariff year T2(FY. 2017-18) of the second control period, whichever is earlier.



- iv. The Airport Operator may also ensure compliance of the Order in respect of the Independent Service Providers at the respective major airports.
