In the matter of Annual Tariff Proposal (ATP) for the fourth tariff year of the first control period submitted by Kerala State Industrial Enterprises Limited in respect of Cargo Services being provided at Calicut International Airport, Kozhikode.

The Authority had considered the Multi Year Tariff Proposal submitted by Kerala State Industrial Enterprises Limited (KSIEL) for cargo services provided at Calicut International Airport, Kozhikode in respect of the first control period of 5 years starting w.e.f. 01.04.2011, and after due stakeholder consultation issued a Multi-Year Tariff Order (MYTO) vide Order no. 3/2011-12 dated 26.07.2011, ordering that the cargo service being rendered by KSIEL at Calicut International Airport, Kozhikode is "*not material*" and hence the Authority may adopt a "*light touch approach*" for determination of tariff for the first Control Period w.e.f. 1.4.2011. Further, based on the documents submitted by KSIEL, the Authority decided and approved the ATP for the cargo service provided by KSIEL at Calicut International Airport, Kozhikode for the first tariff year (2011-12), w.e.f. 15.03.2012, vide Annual Tariff Order No. 36/2011-12 dated 14.03.2012. The Authority also issued Order No. 14/2012-13 and dated 13/08/2012 and Order No. 02/2013-14 dated 12.04.2013 for the second and third tariff year respectively.

2. KSIEL vide letter no. ACC/60(2)/1838 dated 07.03.2014 submitted its Annual Tariff Proposal (ATP) for the fourth tariff year (i.e. 2014-15) of the first control period. KSIEL have stated that its Board has deliberated the proposal for revision in tariff(s) for the fourth tariff year but are not in favour of revising the charges for the fourth tariff year considering that the import cargo volume as well as revenue has come down drastically for the current year and affected the performance of the Company adversely.

3. Under the circumstances, KSIEL has requested for continuation of the existing tariff as notified by the company for the third tariff year in the fourth tariff year also in respect of cargo services provided at Calicut Air Cargo Complex.



4. KSIEL requested the Authority to expedite the orders in the matter, so as to implement continuation of the approved tariff of Third Tariff Year in the Fourth Tariff Year w.e.f. 1st April, 2014.

5. The Authority considered the proposal of KSIEL and observed that KSIEL has not proposed for any change in the already approved the tariff(s) issued vide Order No. 02/2013-14 dated 12.04.2013 and hence decided to determine the tariff(s) for the fourth year as the same as those approved by the Authority for the third tariff year vide Order No. 02/2013-14 dated 12.04.2013.

ORDER

6. Upon careful consideration of material available on record, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airport Economic Regulatory Authority of India Act, 2008, hereby orders that:

- (i) The Tariffs for the fourth tariff year(2014-15) of the first control period are determined to be the same as those of the third tariff year (2013-14) (as approved vide Order No. 02/2013-14 dated 12.04.2013) for Cargo Services provided by M/s Kerala State Industrial Enterprises Limited, at Calicut International Airport, Kozhikode, as at **Annexure-I**
- (ii) These tariffs will be the maximum ceiling and demurrage free period will be as per Government of India instructions issued from time to time.
