In the matter of Annual Tariff Proposal for the First Control Period submitted by Rajasthan Small Industries Corporation Limited (RSICL) for providing Cargo Facility at the Air Cargo Terminal, Jaipur Airport, Jaipur.

M/s Rajasthan Small Industries Corporation Limited (RSICL) submitted its Multi Year Tariff Proposal (MYTP) for five tariff years of first control period (commencing w.e.f. 01.04.2011) in respect of the tariff for the Cargo facility services provided by it at Air Cargo Terminal, Jaipur Airport, Jaipur. The Authority considered the submissions made by RSICL and issued Consultation Paper No. 38/2011-12 dated 22.03.2012 for Stakeholder Consultation. Pursuant to the stakeholders' Consultation, the Authority issued Multi-Year Tariff Order (MYTO) No. 04/2012-13, dated 17.05.2012, as under:

- (i) "The cargo service being rendered by the Rajasthan Small Industries Corporation Limited (RSICL) at Jaipur Airport is 'not material'. Hence, the Authority will adopt a "light touch approach" for determination of tariff for the First Control Period w.e.f. 01.04.2011.
- (ii) The Annual Tariff Proposal for the first and second tariff year may be submitted by RSICL in accordance with the Guidelines."
- 2. After issue of Authority's said order and subsequent communications, it has been noted that RSICL has not submitted any proposal for revision of the tariffs for any of the tariff years of current control period. Thus, it appears that RSICL wishes not to revise the charges for the cargo facility at Air Cargo Terminal, Jaipur Airport, Jaipur from the level as was existing on 31.03.2011.

## 3. ORDER

Upon careful consideration of material available on record, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act 2008, hereby orders that:

i) The tariffs for the first control period (w.e.f 01.04.2011 to 31.03.2016), in respect of cargo facility service provided by M/s Rajasthan Small Industries Corporation Limited at Jaipur Airport are determined, to be the tariffs as were existing on 31.03.2011. In case RSICL wishes to revise these charges, then it may approach the Authority with a suitable tariff proposal.
