In the matter of Annual Tariff Proposal submitted by M/s Celebi NAS Airport Services India Private Limited for third tariff year of the first control period providing Ground Handling Services at CSI Airport, Mumbai.

The Authority had considered the Multi Year Tariff Proposal for the first control period (i.e. 2011-12 to 2015-16) submitted by M/s Celebi NAS Airport Services India Private Limited (Celebi NAS) in respect of the tariff for the services provided for ground handling at CSI Airport, Mumbai and after due stakeholder Consultation issued Multi Year Tariff Order (MYTO) No. 16/2011-12 dated 17.10.2011, ordering that the ground handling service being rendered by Celebi NAS is "material but competitive" and tariff for the same shall be determined under a "light touch approach". Subsequently Celebi NAS submitted its Annual Tariff Proposal (ATP) for first and second tariff years which was considered by the Authority and after due stakeholder consultation, Annual Tariff Order (ATO) No. 33/2012-13 dated 21.01.2013 was issued, determining the tariff for the first tariff year (2011-12) and second tariff year (2012-13) of the first five year control period.

2. Thereafter, Celebi NAS submitted their Annual Tariff Proposal for third tariff year (2013-14), vide submission dated 04.03.2013.

3. The Authority considered the submission made by Celebi NAS and issued Consultation Paper No. 5/2013-14 on 17.04.2013, wherein the ATP for third tariff year was put up for stakeholder consultation.

4. In response to the said Consultation Paper, comments have been received from Mumbai International Airport Private Limited (MIAL). MIAL in its comments has agreed to the proposal contained in the Consultation Paper and requested approval of the ATP for third tariff year submitted by Celebi NAS.

ORDER:

5. Upon careful consideration of material available on record, the Authority, in exercise of powers conferred by Section 13 (1) (a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:

- (i) The tariff for the Third Tariff Year (w.e.f. 01.04.2013 to 31.03.2014) of the first control period for the Ground Handling Services provided by M/s



Celebi NAS Airport Services India Private Limited at CSI Airport, Mumbai is determined, as at per **Annexure - I**.

- (ii) These tariffs will be the maximum tariffs and will be effective from 01.04.2013.

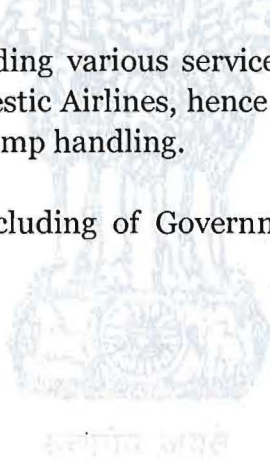
