In the matter of Annual Tariff Proposal submitted by M/s Bhadra International India Ltd. for Third Tariff Year (2013-14) of the first control period for providing Ground Handling Services at Thiruvananthapuram International Airport, Thiruvananthapuram.

The Authority had issued Multi-Year Tariff Order no. 8/2012-13 dated 19.06.2012 in respect of M/s Bhadra International India Limited (Bhadra) for providing ground handling services at Thiruvananthapuram International Airport, Thiruvananthapuram wherein the Authority, after stakeholder consultation, had decided to adopt "light touch approach" for tariff determination for the first Control period w.e.f. 01.04.2011 and had also determined the tariffs for the first tariff year i.e.2011-12. Thereafter, the Authority issued Order No. 41/2011-12 dated 26.02.2013 determining the tariff for the second tariff year (2012-13).

- 2. Bhadra vide, its letter no. Bhadra/AERA-tariff/2012-13 dated 19.02.2013, requested the Authority "to kindly consider and approve the same rate as proposed by Bhadra for the first tariff year of the first control period for the 3<sup>rd</sup> tariff year also in respect of all the four airports namely Chennai, Kolkata, Trivandrum and Calicut Airport" for the ground handling services provided at these airports.
- 3. The Authority considered the submission made by Bhadra and issued Consultation Paper No. 1/2013-14 on 01.04.2013.
- 4. No comments have been received from stakeholders in response to the proposal contained in the Consultation Paper No.01/2013-14 dated 01.04.2013.

#### ORDER

5. Upon careful consideration of material available on record, the Authority, in exercise of powers conferred by Section 13(1)(a)of the Airport Economic Regulatory Authority of India Act, 2008, hereby orders that:

- i) The Tariffs for the third year (2013-14) of the First Control period for ground handling services provided by M/s Bhadra International India Ltd, at Thiruvananthapuram International Airport, Thiruvananthapuram is determined as at Annexure-I, w.e.f. 01.04.2013
- ii) The instant determination permits M/s Bhadra International India Ltd to only charge/levy certain tariffs for ground handling services provided by it at Thiruvananthapuram airport, and does not confer any rights/claims whatsoever on M/s Bhadra International India Ltd for appointment as service providers for providing any service at Thiruvananthapuram airport. Further, for this purpose, this order will not affect the rights of any party in this matter.
