In the matter of determination of Annual Tariff for First and Second Tariff Years of the First Control Period in respect of Bird Worldwide Flight Services (India) Private Limited for Providing Ground Handling Services at Cochin International Airport, Cochin.

The Authority had considered the Multi Year Tariff Proposal (MYTP) for the first Control Period (i.e. 2011-12 to 2015-16) submitted by Bird Worldwide Flight Services (India) Private Limited (BWFS) in respect of the services provided for ground handling facility at Cochin International Airport, Cochin and after due stakeholder Consultation, issued Multi Year Tariff Order (MYTO) No. 39/2011-12 on 19.03.2012, ordering that the ground handling services provided by BWFS is "material but competitive" and tariffs for the same shall be determined under a "light touch approach".

2. BWFS submitted their Annual Tariff Proposal (ATP) for first tariff year (2011-12) and the second tariff year (2012-13).

3. The Authority considered the submissions made by BWFS and issued Consultation Paper No. 24/2012-13 on 12.10.2012 wherein the ATPs for first and second tariff year, were put up for stakeholder comments. No comments have been received from stakeholders in response to the Consultation Paper No. 24/2012-13.

ORDER

4. Upon careful consideration of material available on record, the Authority, in exercise of powers conferred by Section 13(1) (a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:
