In the matter of Economic Regulation of aeronautical services provided by Independent Service Providers of Cargo Facility, Ground Handling and Supply of Fuel to the Aircraft – Interim arrangement to continue the levy of tariff beyond 30.09.2019 for the First control Period.

M/s BPCL-KIAL Fuel Farm Limited (BKFFPL) at Kannur Airport has submitted its MYTP/ATP to the Authority for the First Control Period which is under process and will take some more time for determination of tariff. Hence M/s BKFFPL may be allowed to charge the lower tariff as proposed by them in ATP for FY2019-20 upto 31.12.2019 or till the date of determination of tariff by AERA, whichever is earlier.

ORDER

In view of the above, to avoid any regulatory vacuum in respect of the tariff(s) being levied by the regulated entities, the Authority, in exercise of powers conferred by Section 13(1) of the Airport Economic Regulatory Authority of India Act, 2008 hereby orders that:-

(i) M/s BPCL-KIAL Fuel Farm Limited is allowed to levy tariff (as proposed in their ATPs) as per Annexure-I upto 31.12.2019 or till the date of determination of tariff by AERA whichever is earlier.
