Sub: In the matter of *ad-hoc* tariff for aeronautical services to be provided at Navi Mumbai International Airport (NMIA) w.e.f. the Commercial Date of Operation ("COD").

1. Background:

Navi Mumbai International Airport Private Limited (NMIAL) entered into a Concession Agreement with the City and Industrial Development Corporation of Maharashtra Limited (CIDCO) on January 8, 2018 to establish a greenfield airport in Navi Mumbai (NMIA) on Design, Build, Finance, Operate and Transfer (DBFOT) basis for a period of 30 years commencing from the Appointed Date i.e., July 7, 2018, further extendable for another 10 years subject to the terms of the Concession Agreement.

Navi Mumbai International Airport Private Limited (NMIAL, the Concessionaire) is a special purpose vehicle established for construction, operation and maintenance of the greenfield international airport project at Navi Mumbai, Maharashtra, on a Design, Build, Finance, Operate and Transfer (DBFOT) basis. NMIAL is owned by Mumbai International Airport Limited (MIAL) [74% shareholding] and City and Industrial Development Corporation of Maharashtra Limited (CIDCO) [26% shareholding].

Mumbai has an existing international airport in the city, called Chhatrapati Shivaji Maharaj International Airport (CSMIA), being operated by MIAL. CSMIA has both landside and Airside constraints for expansion, and therefore, the need for second airport was felt to serve the Mumbai Metropolitan Region (MMR) along with CSMIA. After operationalization of the Greenfield airport, Mumbai will have a dual airport ecosystem and passengers will have an option to fly from either of the two airports.

2. Multi Year Tariff Proposal submission by NMIAL

- 2.1 Navi Mumbai International Airport Private Limited vide letter dated February 7, 2025, submitted the Mutli Year Tariff Proposal (MYTP) under hybrid till for NMIA.
- 2.2 The Airport Operator has indicated to achieve Commercial Operation Date ("COD") by August 2025 and the First Control Period will be from April 1, 2025 to March 31, 2030.
- 2.3 Airport Operator has submitted details pertaining to Master Plan, Concession requirements, traffic projections, Capital Expenditure (Passenger Terminal building, Runways and Taxiways, Apron, Cargo, Fuel Farm etc.), Depreciation, Regulatory Asset Base, Fair Rate of Return, Operation and Maintenance Expenditure, Non-aeronautical Revenue, Taxation and Aggregate Revenue Requirement etc. A brief on regulatory components of MYTP proposed by the Airport Operator are given under:
 - i) Capital Outlay Plan: Airport Operator has proposed to infuse an amount of Rs. 57,333 crore (approx.) on creation of airport facilities in the Navi Mumbai International Airport during the first three phases out of five phases. During the first and second phase, it has been proposed to spend an amount of Rs. 22,531 crore as the capital expenditure.
 - ii) <u>Design capacity</u>: The phase-wise capacity envisaged at the Navi Mumbai International Airport as per the master plan is given hereunder:

3. Tariff Determination Process of AERA

Following facts are relevant with regard to Tariff Determination Process of AERA:

- As per clause (i) of Section 2 of the AERA Act, 2008 (read with subsequent amendment of 2019 and 2021), 'Major Airport' means any airport which has, or is designated to have, annual passenger throughput in excess of three and a half million or any other airport or group of airports as the Central Government may, by notification, specify as such. As the designated capacity of NMIAL (as per master plan) during the FY 2025-26 is **20 million**, and AERA accordingly vide its Public Notice No. 05/2024-25 dated 21.06.2024 has decided to consider Navi Mumbai Airport as a Major Airport.
- 3.2 Section 13 of the AERA Act, 2008 pertaining to the 'Functions of the Authority', inter-alia, includes 'determination of tariff for the aeronautical services in respect of the Major Airport'. In view of the mandate given under AERA Act, 2008, (read with subsequent amendment of 2019 and 2021), the Authority has initiated the tariff determination process on the proposals submitted by NMIAL in their MYTP submissions for tariff determination.
- 3.3 The Tariff Determination process for the aeronautical services is very comprehensive and exhaustive exercise involving following major steps:
 - i) Detailed analysis of Capex proposed by the Airport Operator vis-à-vis the proposed capacity of the airport and likely traffic to be handled, to ensure that only efficient Capex is allowed.
 - ii) To determine the Aggregate Revenue Requirement for the Regulated Service for the First Control Period taking into consideration 'Regulatory Asset Base', 'Fair Rate of Return', 'Depreciation', 'Efficient Operation and Maintenance Expenditure', 'Taxation', 'Non-aeronautical Revenue' and 'Yield Per Passenger' for the Control Period.
 - iii) To put in public domain the proposals of the Authority in the form of Consultation Paper for soliciting feedback/comments/views of the stakeholders, analysis of all the stakeholders' comments and counter comments.
 - iv) To issue Multi Year Tariff Order for the Control Period upon due consideration of stakeholders' comments and counter comments on the Consultation Paper.

3.4 The MYTP submitted by NMIAL is under examination at AERA and in the backdrop of comprehensive tariff determination process, as brought out above, issuance of final Tariff Order in respect of Navi Mumbai International Airport may take some time.

4. Request for ad-hoc tariff for interim period by NMIAL

- 4.1 NMIAL vide letter dated February 12, 2025, has submitted a proposal for adhoc tariff till the time approval for regular/final tariff is granted by the Authority. Subsequently, the Airport Operator submitted Variable Tariff Proposal (VTP) on April 17, 2025. The Tariff Rate Card submitted by the Airport Operator is attached at **Annexure-A.** The Airport Operator vide its mail dated June 04, 2025 and June, 17, 2025 has requested to expedite the process for issuance of ad-hoc tariff. Further, NMIAL has submitted revised tariff rate card on June 20, 2025 for Cargo Handling Charges.
- The Airport Operator vide its request for ad-hoc tariff has sought YPP of Rs. 1,798 as ad-hoc tariff against the YPP of Rs. 3,568 (in absolute terms) for the Control Period.

5. Ad-hoc Tariff considered by AERA

The Authority notes that Navi Mumbai Airport being a Greenfield Airport, wherein there is no prevailing tariff rates available to be levied on the date of commencement of actual Commercial Operation. Upon receipt of MYTP from the Airport Operator (refer para 2.1), determination of regular tariff as per AERA Tariff Guidelines and other relevant orders issued from time to time requires a very thorough, comprehensive and in-depth examination of each regulatory building block including independent study on capex etc. followed by stakeholder consultation meeting allowing reasonable time for comments, counter comments etc. and this entire exercise of regular tariff determination takes some time. In the background of the above, need arises for issuance of adhoc tariff order, to avoid regulatory vacuum at the Major Airport. AERA has issued ad-hoc tariff orders in the past also and shall continue to do so in future, as and when need arises, particularly for Greenfield Airports.

The clause 2.2.5 of the Memorandum of Understanding (MoU) executed between GoI and the concessionaire (NMIAL) dated April 11, 2018 also stipulates as under:

"..... the concessionaire shall be entitled to levy, collect and appropriate the aeronautical charges with effect from Phase I from COD as per clause 15.1.1 of concession agreement from the users of the airport, at the initial/ad-hoc rates of the tariff approved by AERA. Such initial or ad-hoc rates of tariff shall be applicable and valid until the approval of aeronautical charges by AERA......"

5.2 The Airport Operator has asked for regular tariff based on the various building blocks as listed in para 2 above. The Authority is conscious of the fact that Airport Operator has projected its proposal based on building blocks as per their own assessment/estimates while AERA does its thorough prudence check and due diligence while deciding its approach on each building block in tariff determination exercise based on efficiency, cost relatedness, etc. in terms of Capex and Opex and other building blocks. Experience shows that there is a

- difference between projections provided in MYTP and those decided by AERA after going through the scrutiny.
- 5.3 As stated above in para 3.4, tariff determination process may take some time and in the interim period ad-hoc Tariff needs to be decided by AERA as requested by the Airport Operator.
- 5.4 After consideration of all the relevant facts and figures and for the interest of all stakeholders, Authority decides:
 - 5.4.1 Proposal of the Airport Operator for UDF and landing needs to be rationalized and moderated. The Authority notes that the tariff rate card given by the Airport Operator for cargo operations is very complex in nature. Presently, the Authority has considered the same for ad-hoc tariff purpose.
 - 5.4.2 However, the Airport Operator is directed to simplify the structure of tariff rate card for cargo handling services during regular tariff determination. Further, these charges and line items (considered on adhoc basis) will be rationalized and simplified based on the stakeholders' comments/ feedbacks received during the regular tariff determination process of Navi Mumbai Airport with the objective of enabling the growth and efficiency in cargo services in the region.
 - 5.4.3 The Authority notes that the Airport Operator has not submitted the tariff rates for cargo handling services relating to Air Freight Station (AFS). The Authority, taking note of the AFS Policy of MoCA and has considered 30% lower Terminal Storage & Processing (TSP) charges for AFS cargo (as compared to normal cargo) in the Tariff Rate Card for International cargo handling services, as an enabling provision, which shall be implemented as and when NMIAL commence cargo handling service for AFS cargo.
 - 5.4.4 The Airport Operator has also submitted Variable Tariff Plan (VTP) in respect of Landing Charges applicable for International Operations and the Authority observes that the VTP is to bring additional flights at the new Greenfield Airport. The Authority considers the same as ad-hoc tariff. However, the same will be examined in detail during the regular tariff determination exercise. In this regard, the Authority directs NMIAL, to ensure that the principles of non-discrimination of ICAO guidance are not violated.
 - 5.4.5 Accordingly, the Authority after analyzing on a broad basis each of the regulatory building block particularly CAPEX as contained in the MYTP of the Airport Operator and after deliberations and consultations with the Independent Consultant who has been engaged by the Authority for NMIA regular tariff determination exercise, decides the aeronautical tariff for landing, parking and UDF, etc. on ad-hoc basis as per Annexure-B (B1, B2, B3).
- The Authority decides to allow charging/levying ad-hoc tariff/UDF rates (w.e.f commercial operation date) as an interim measure, till March 31, 2026 or final determination of regular tariff, whichever is earlier. The revenue to be collected by NMIAL on ad-hoc basis in the interim period, shall be accounted for by the Authority during the regular tariff determination exercise of NMIA.

Conomic Regulatory A

Any concession offered by Airport Operator to Airport Users from the approved ad-hoc tariff rate card by the Authority as per Annexure-B would be on their own volition, and are not accounted for in tariff determination exercise as per Tariff Determination methodology of AERA.

Order

- 6. In exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, the Authority hereby orders that:
 - i) The Navi Mumbai International Airport Private Limited (NMIAL), is allowed to levy and collect the tariff for Aeronautical Services, on ad-hoc basis as per **Annexure-B** (B1, B2 & B3), w.e.f Commercial date of operation ("COD") to March 31, 2026, or, till the determination of regular Aeronautical Tariff for the First Control Period, whichever is earlier.
 - ii) In exercise of powers conferred by Section 13(1)(b) of the AERA Act, 2008, read with Rule 89 of the Aircraft Rules, 1937, the Authority hereby determines the rate of UDF on ad-hoc basis as indicated in the tariff rate card at **Annexure-B (B1)**.
 - iii) This order shall be made effective subject to receipt of all the requisite regulatory and statutory approvals before the commencement of operations at NMIA.
 - iv) Tariff determined, as above, is the maximum Tariff(s) to be charged from the Users and no other charges are to be levied over and above the approved Tariff.
 - v) The Tariff approved, as above, is excluding of all applicable Govt. taxes, if any.

Collection charges on User Development Fee (UDF): Scheduled Passenger Airlines will be entitled for Collection Charges of Rs. 2.50 /- (Rupees two and fifty paisa only) per Embarking & Disembarking Passenger (excluding the number of passengers exempted from paying such a charge), provided (a) NMIAL receives the invoiced UDF amount within the due date mentioned in the invoice; and (b) there are no overdue on any account with NMIAL. The collection charges so payable to the Airline will be adjusted by Credit Note during the subsequent billing cycle. However, no collection charge shall be payable by NMIAL to the airline if the airline fails to make UDF invoice payment within aforesaid applicable time limit/credit period.
- 2. For calculating UDF in Foreign currency, the RBI conversion rate as on the last day of the previous month for tickets issued in the first fortnight and rate as on 15th of the month for tickets issued in the second fortnight shall be adopted.
- 3. UDF (Domestic / International) will be determined and levied based on ultimate destination in particular ticket / PNR.
- 4. Exemptions in Payment of User Development Fee (UDF) In terms of DGCA AIC No. 14/2019 dated 16.05.2019 and AIC No. 20/2019 dated 06.11.2019 (decision of Ministry of Civil Aviation, Govt. of India vide order no. AV 29012/39/2018-AD dated 30.10.2019) the following categories of persons are exempted from levy and collection of UDF:

- g) Passengers Embarking from the Indian airports due to involuntary rerouting i.e. technical problems or weather conditions.

- 1. All above mentioned charges (Landing, Parking, UDF, Fuel Infrastructure Charges, ICT (CUTE / CUSS / BRS) Charges, X-Ray Baggage Charges, Aerobridge Charges and BME Charges) are exclusive of applicable taxes.
- 2. All the charges applicable (a) to Indian Carriers (including international operations) will be in Rs. / INR; and (b) to Foreign carriers in USD.
- 3. Invoice for the above charges shall be raised by the Airport Operator on weekly basis and the invoice shall include applicable taxes.
- 4. Aviation Security Fee (ASF) (previously Passenger Service Fee (PSF) Security) shall be applicable as prescribed by MoCA from time to time.
- 5. Flights operating under Regional Connectivity Scheme will be exempted from charges as per Order No. 20/2016-17 dated 31.03.2017 of the Authority from the date the scheme is operationalized by the GOI as amended from time to time.
- 6. For all the above charges, the Airlines will be allowed a credit period as may be decided by NMIAL from time to time, subject to approval of credit limits by NMIAL.
- 7. If the invoice for any of the airport charges is not paid within the credit period, interest shall be charged at the rate of one and half percent (1.5%) per month and shall be charged on pro-rata basis for each day of delay.
- 8. Payment received from the airlines shall first be appropriated towards the interest due in case of overdue and unpaid invoices. Thereafter, surplus/remaining amount, if any, shall be applied towards principal dues in chronological order.
