The Authority had considered the Multi Year Tariff Proposal (MYTP) for the first control period commencing from 01.04.2011 submitted by Celebi NAS Airport Services India Private Limited (Celebi NAS) in respect of the ground handling services provided at CSI Airport, Mumbai. After due stakeholder consultation, the Authority issued a Multi Year Tariff Order (MYTO) No. 16/2011-12 dated 17.10.2011, ordering that the ground handling services rendered by Celebi, CSI Airport, Mumbai is **“material but competitive” and hence the Authority will adopt a “light touch approach”** for determination of tariff for the first control period w.e.f.01.04.2011. Thereafter, the Authority also determined the tariffs for the first and second Tariff years (2011-12 & 2012-13) vide Annual Tariff Order (ATO) no. 33/2012-13 dated 21.01.2013.

2. **As per Clause 7.4 of the Authority’s Guidelines [Airports Economic Regulatory Authority of India (Terms and Conditions for Determination of Tariff for Services Provided for Cargo Facility, Ground Handling and Supply of fuel to the Aircraft) Guidelines, 2011]**, after issuance of the MYTO, the service provider shall submit to the Authority its Annual Tariff Proposal (ATP), provided that an ATP shall be submitted at least 75 days prior to the start of the Tariff Year. Clause 11.2 of the Guidelines provided that the, ATP is required to be submitted in the form and manner as provided in Appendix A1.8.2 wherein it is mentioned that the ATP should be supported by:

- Form B and Form F14 (b),
- Details of consultation with stakeholders
- Evidence of User Agreements clearly indicating the Tariff (s) proposed by the service Provider.

3.1 Celebi NAS, vide letter no. nil dated 04.03.2013, have submitted Form B, and Form 14(b) towards ATP for third tariff year (2013-14) of the first control period.

3.2 In their conditions for tariff, (in the Annexure- I and II of their proposal) Celebi NAS have stated the following:

**Annexure - I Price List for International & Domestic Aircrafts**

## **Annexure - II Price List for Corporate Aviation**

*“ \* Prices were not revised since start of the operation i.e. in October 2009, however Wholesale Price Index (WPI) has increased by 29% (Oct'09-131 vs Jan'13-169.2). Considering the increase in cost of operation, which is evident from WPI increase, Celebi NAS hereby propose to increase the prices by 25% first time in three and half years.”*

4. The Authority has carefully considered the ATP submitted by Celebi Nas Airport Services India Private Limited for Ground Handling services being provided at CSI Airport, Mumbai and decided to make the following proposal for stakeholder consultation:

- (i) The Tariff for the third tariff year (w.e.f. 01.04.2013 to 31.03.2014) of the first control period for Ground Handling Services provided by Celebi Nas Airport Services India Private Limited at CSI Airport, Mumbai, are tentatively decided to be as at **Annexure - I.**

5. In accordance with the provisions of Section 13(4) of the AERA Act, 2008, the proposal contained in para 4 above is hereby put forth for stakeholder consultation. To assist the stakeholders in making their submissions in a meaningful and constructive manner, necessary documents are enclosed as **Annexure - II.** For removal of doubts; it is clarified that the contents of this Consultation Paper may not be construed as any Order or Direction of this Authority. The Authority shall pass an Order, in the matter, only after considering the submissions of the stakeholders in response hereto and by making such decision fully documented and explained in terms of the provisions of the Act.

6. The Authority welcomes written evidence-based feedback, comments and suggestions from stakeholders on the proposal made in para 4 above, **latest by 01.05.2013** at the following address:


