TO CONSIDER THE ANNUAL TARIFF PROPOSAL FOR THE FY 2018-19, FY2019-20 & FY2020-21 IN RESPECT OF M/S DELHI CARGO SERVICE CENTER PVT. LIMITED (DCSC) FOR PROVIDING CARGO HANDLING SERVICES AT INDIRA GANDHI INTERNATIONAL AIRPORT, NEW DELHI.

New Delhi: 16th Aug, 2018.

AERA Building Administrative Complex Safdarjung Airport. New Delhi.

1. Brief Back:

M/s Delhi Cargo Service Centre Pvt. Ltd. (DCSC) is one of the Cargo Handling agencies appointed by Delhi International Airport Limited (DIAL) for carrying out Cargo Handling (CH) at Indira Gandhi International Airport, New Delhi. The Authority, vide its MYTO Order No. 02/2017-18 dated 11.05.2017 decided to adopt 'Light Touch Approach' in respect of the DCSC for Cargo Services at IGI Airport for determination of tariff for Second Control Period. Subsequently, the Authority also determined the Annual tariff for FY 2016-17 and FY2017-18 wherein an increase of 7% was allowed as requested by the party.

2. <u>Annual Tariff Proposal (ATP)/Annual Compliance Statement (ACS)</u> <u>Submissions made by DCSC for FY2018-19 of Second Control</u> <u>Period</u>.

M/s DCSC vide their letter dated 02.02.2018 submitted their ATP for FY2018-19(Annexure I) with proposed average increase of 34% on the existing tariff. Further, M/s DCSC submitted the following documents for the determination of tariff for FY2018-19:

- a) Audited Balance Sheet for FY2016-17 and unaudited Balance Sheet for FY2017-18.
- b) Audited Annual Compliance Statement (ACS) for FY2016-17(Annexure II).
- c) The Concession Agreement entered with DIAL.
- d) Key User Agreements for examination of the Authority.
- e) The evidence/minutes of the stakeholder consultation conducted on 07.11.2017 for the proposed tariff increase of 34% for the year FY2018-19(Annexure III).
- f) The Capital Work in Progress (CAPEX) and their capitalisation report for the year FY2018-19. Actuals and Projections of CAPEX for the Second Control Period
- g) Calculations on Aggregate Revenue Required (ARR) by M/s DCSC for FY18-19, FY2019-20 & FY2020-21(Annexure IV).

3. <u>Determination of Aeronautical Tariff under "Light Touch</u> <u>Approach"</u>.

a) The Authority vide its Order No. 02/2017-18 dated 11.05.2017 decided to adopt 'Light Touch Approach' for the Second Control Period (FY. 2016-17 to FY. 2020-21).

4. Authority's Examination on the proposal.

a. The services rendered by M/s DCSC for providing Cargo Handling facility at Indira Gandhi International Airport, New Delhi are aeronautical services in terms of section 2(a) of the Airports Economic Regulatory Authority of India Act, 2008 (Act) and under section 13 (1)(a) of the Act, the Authority is required to determine tariff for aeronautical services.

- b. The Authority observed that M/s DCSC has conducted Stakeholder Consultation with the users on 07.11.2017 for the proposed ATP in accordance to AERA guidelines for FY 2018-19 wherein, M/s DCSC has proposed an increase of 34% in an average on the existing tariff. However there is no comment of the stakeholder on the propose hike in the minutes of meeting.
- c. The Authority observed that M/s DCSC as per concession agreement with DIAL has to develop a plot measuring 20,000 sq.mts. for further development of Cargo Terminal, within a period of five years from the effective Date of execution of concession agreement. The Authority observed that as per the submission of M/s DCSC the above mentioned project is getting capitalized in the year FY2018-19 at a project cost of Rs. 37.50cr. In addition, the investment in Plant & Machinery and Furniture & Fixtures is Rs.2.46 cr.
- d. The Authority observed that the audited balance sheet for FY2016-17 shows a loss of Rs.3.22cr. and balance sheet for FY2017-18 shows a loss of Rs.5.85cr. Further the audited balance sheet for FY2016-17 shows accumulated deficit/losses of Rs.39cr as on 31.03.2017. The Authority decided to consider the prior period losses/deficit of FY2016-17 & FY2017-18 only (period relating to the control period) while calculating Aggregate Revenue Required (ARR) for FY2018-19.
- e. The Authority observed that Based on the ACS submission by DCSC a comparative scenario of revenue, cost and return on average RAB for the FY2015-16 & FY2016-17 is prepared and annexed as "Annexure-V". The Authority observed the following parameters in the financials as submitted by DCSC:
 - i) Return on Average RAB for FY2016-17 stands at -2%.
 - ii) The turnover % in FY 2016-17 is -2%.

It is pertinent to mention that the Authority vide order no. 02/2017-18 dated 11.05.2017 determined tariff for FY 2016-17 and FY2017-18 wherein, M/s DCSC was allowed to continue with the same rates of FY2016-17 for FY2017-18.

f. The Authority observed that M/s DCSC in their submissions vide their letter dated 02.02.2018 proposed/requested for tariff increase of 34%. The Authority observed the increase/trend in volume year on year and calculated the Common Annual Growth Rate (CAGR) which works out to 11.50% during last 6 years. The Authority after due deliberations and after considering the CAGR for increase in volume (annually) decided to consider 25% increase in tariff for FY2018-19 and 20% in FY2019-20 and 3% FY2020-21 since the growth may not sustain for long period. Further, the Authority decided that the increase/hike in tariff for FY2018-19, FY2019-20 and FY2020-21 and its implications would be analysed/scrutinised at the end of Second Control Period. The brief of calculations and the projections assumed is as follows (Rs. In Crores):

Projections taken to arrive at ARR is as follows:

- a) Shortfall/under recovery of FY2016-17 & FY2017-18 is added to ARR of FY2018-19.
- b) Projected Volume increase CAGR@11.50% in FY2018-19.
- c) Revenue from Non-Regulated Services taken as average of actuals.
- d) Operating Expenditure/personnel Expenses taken at the increase of @ 10%.
- e) Capital Expenditure taken as projected by DCSC with supporting documents in the form of invoices & loan documents.
- f) Return on average RAB taken as 13.07%.(FRoR)

5. Proposal

The Authority, after careful consideration of the ATP for FY2018-19 (2nd Control Period), makes the following proposal for stakeholder consultation:

- 5.1 The Authority in accordance to the provisions of Chapter V of the AERA Guidelines vide its Order No. 02/2017-18 dated 11.05.2017 decided that the tariff for M/s DCSC will be determined under "Light Touch Approach" for the duration of Second Control Period (01.04.2016 to 31.03.2021) and accordingly issued the MYTO for the 2nd control period.
- 5.2 The Authority is of the view that 'the Guidelines' need not be followed in a routine manner. Further even in 'Light Touch approach', the Authority examines the margins, the increase in profit and return on RAB to ensure that extraordinary profits do not accrue to the service provider and that the ultimate customer is not burdened with higher tariffs as the latter does not have much say in the User Agreements.
- 5.3 Moreover in view of fact stated at para 4c, 4d, 4e & 4f, the Authority examined and calculated the expected Revenue, Cost, RAB, Return on Investment etc. A statement to the effect has been placed at Annexure-V. Based on the statement it is proposed that M/s DCSC may be allowed to charge with an increased tariff of 25% on the existing tariff for FY2018-19 and 20% for FY 2019-20 and 3% for FY2020-21 such that the Authority can analyse the impact of determined tariff for longer period/duration and to allow M/s DCSC to sustain the rise in operating expenditure predominantly due to revision of minimum wages and CAPEX getting

capitalised in FY2018-19. The proposed tariff from the date of issue of this order to 31.03.2021 of the second control period for Cargo Handling Services provided by M/s DCSC at IGI Airport, New Delhi is placed at **Annexure-VI.** However the ARR and Revenue will be trued up at the end of Control Period. Further any surplus/loss arisen in FY2019-20 & FY2020-21, due to determined tariff for FY 2018-19 FY2019-20 and FY2020-21 would be adjusted in Third Control Period (FY2021-22 to FY 2025-26).

- 5.4 The Authority will issue the final order only after considering the written comments/observations of the stakeholders.
- 5.5 Tariff determined as above will be maximum tariff to be charged. No other charge is to be levied over and above the approved tariff.
- 5.6 In accordance with the provisions of Section 13(4) of the AERA Act, the proposal contained in para 5 above is hereby put forth for stakeholder consultation. To assist the stakeholders in making their submissions in a meaningful and constructive manner, necessary documents are enclosed as annexures to the consultation paper. For removal of doubts, it is clarified that the contents of this Consultation Paper may not be construed as any Order or Direction of this Authority. The Authority shall pass an Order, in the matter, only after considering the submissions of the stakeholders in response here to and by making such decision fully documented and explained in terms of the provisions of the Act.






5. TARIFF PROPOSAL AND JUSTIFICATION FOR INCREASE, IF ANY: -

TARIFF PROPOSAL

For the Year 2017-18, DCSC is proposing to increase the overall tariff for International and Domestic Cargo Handling Services for the Financial Year 2018-19, w.e.f. 1st April, 2018.

JUSTIFICATION FOR INCREASE

i) Delay in approval of tariff :-

DCSC applied for tariff increase of 7% for the first tariff period (FY.2016-17) in January 2016 but authority (AERA) approved the same only in May 2017 hence implementation of revised tariff rates was delayed by nearly 14 months. This contributes to the incremental revenue loss to the tune of Rs.10 Crores.

- ii) Increase in Operating Cost:-
 - (a) Salary Cost : Delhi government had brought forward in two upward revisions in the minimum wages rates by almost by 43% in the period from Jan 2017 to May 2017.
 - (b) Land License fees : Automatic increase in land license fees by 7.5 % every year payable to DIAL .
 - (c) Electricity & Other Administrative Overheads : Other operating expenses i.e electricity & Other Administrative Overheads have also gone up. Besides that general increase in other operating costs is caused due to inflation (7% Increase as indicated by CPI Index).
- iii) Drop in volume of cargo :- The volume of the cargo development did not happen as expected. For Delhi Cargo Service Center Pvt. L

Lower volume of cargo coupled with increase in operating cost primarily manpower cost necessitate increase in tariff for various services as compared to previous year. Due to this company is making losses since beginning. To survive, it needs to cover the cost of operations in order to sustain its business in the overall interest of the trade and commerce.

After the presentation was over ,Mr.Vipan Jain opened the floor for the participants' feedBack ,questions and clarifications for the proposed changes

- The trade member wanted to know the other infrastructure created in last two years. Mr. Vipan Jain explained that DCSC was using COSYS system run on Oracle 12C, most advanced system. Additionally, 10 Ton ULD & two 5 Ton Loose Cargo Hoist installed for faster intake and delivery for import Cargo. Launch of Mobile App- Turant CSC, Dash Boards-Live Displays, Track and Trace-DCSC Portal etc.
- The trade member enquired about the present operating structure and suggested that the less increment in regular tariff for customer point of view.
 Mr. Vipan Jain replied that one of the highest input cost salary has arisen by 43% (As per govt. notification wages increased on 19th Jan'17 by 40% and again on 1st April by another 3%).

 The trade member, trade raised their point about the reasons for increase in cost beside manpower.

Mr. Vipan Jain replied that Automatic increase of 7.5% in Land License payable to DIAL Y-o-Y Basis and some increase in cost of electricity as well.

- Point of business loss was pointed out by Mr. Panalpina that whether there be another increase in tariff if there would be further drop in business.
 Mr. Venugaopal Bangera, CEO of the Company, advised that increase is subject to user consultancy meeting and further approval of AERA.
- The trade member wanted to know the tonnage and volume increase in the last year. CEO replied with all the facts and figures by stating that DCSC was more or less at the same volume like last year. Air India was added in the business, but at the same time, AIR France & KLM airlines shifted to our competitor. He also informed that INDIGO which was doing the business equivalent to other three carriers also moved on.

Mr. Venugopal Bangera, CEO DCSC ,explained to their trade partners ,DCSC's Investment plans & detailed justification behind the proposed increase in the tariff for majority of tariff items by 34% for International and Domestic Cargo Handling Services for the Financial Year 2018-19 sought by DCSC in their Annual Tariff proposal.
