**Sub:** Submission of the Tariff Rate Card for the First Control Period from 1<sup>st</sup> April 2025 to 31<sup>st</sup> March 2030 (FCP) of Navi Mumbai International Airport Private Limited, Navi Mumbai (NMIAL).

**Reference:** Consultation Paper no 08/2025-26 issued on 17<sup>th</sup> March, 2026 (CP)

Dear Sir,

This has reference to the subject CP published by the Authority, in the matter of determination of aeronautical tariff for NMIAL for the FCP.

At the outset, NMIAL would like to appreciate the hard work put in by the Authority while conducting the due diligence of Multi Year Tariff Proposal (MYTP) submitted by NMIAL for the FCP and releasing the CP in a timebound manner.

NMIAL would be submitting detailed responses w.r.t the proposals put forth by the Authority in the CP as part of the stakeholder's consultation process within the stipulated period. NMIAL requests Authority to kindly consider submissions/responses while finalizing the Aggregate Revenue Requirement (ARR) for the FCP and provide NMIAL an opportunity to revise the Tariff Rate Card, prior to issuing the tariff order based on the final decision of the Authority.

After detailed planning, with the vision to transform Mumbai Metropolitan Region, we hereby submit Tariff Rate Card for NMIAL considering the following underlying factors:


- The effective date for implementation of the Tariff Rate Card has been considered as 1<sup>st</sup> July 2026.
- While setting the tariff, complying with Section 13 of the AERA Act, it is essential for AERA to ensure the economic and viable operations of the airport.

- The proposed Tariff Rate Card (refer Annexure A) is derived based on traffic as proposed in the CP.

1. Weight of an aircraft means Maximum Take-Off Weight (MTOW) in MT (i.e. 1,000 Kg) as indicated in the Certificate of Airworthiness (CoA).
2. Landing charges shall be calculated on next rounded-off MT (i.e., 1000 kg)
3. The above mentioned rates are Rack Rates (RR), wherever necessary in the proposed Tariff rate card.
4. Domestic legs of international routes of Indian operators to be treated as domestic flights as far as landing charges are concerned, irrespective of the flight numbers assigned to such flights.
5. A minimum charge of Rs. 10,000/- shall be levied per single unscheduled landing of helicopter and general aviation aircraft. For over the specified tonnage, the charges as per MTOW will be applicable.
6. No landing charges shall be payable in respect of:
  - a. Aircraft with a maximum certified passenger capacity of less than 80 seats, being operated by domestic scheduled operators at the airport.
  - b. Training flights operated by DGCA approved flying schools/flying training institutes.
  - c. Helicopters of all types (not applicable to non-scheduled operators).
  - d. Military aircraft (Government of India) including para-military forces such as BSF, Coast Guard etc.

1. Weight of an aircraft means MTOW in MT (1000 kg) as indicated in the certificate of airworthiness filed with DGCA.
2. The charges set forth herein shall be calculated based on the next rounded off MT and for calculating chargeable parking time, part of an hour shall be rounded off to the next hour.
3. Free parking is allowed on all aircraft stands (Contact and Remote) for the first two hours.
4. For the next two hours and beyond four hours, parking rates as mentioned above shall be applicable.
5. Parking time will be calculated based on On-Blocks and Off-Blocks time as recorded at the Airport Operations Control Centre (AOCC).
6. In case of an aircraft being parked beyond 24 hours due to technical or any other reasons, the parking charges shall be levied on a weekly basis in line with this Tariff rate card.

**Charges for Unauthorized Overstay in case of General Aviation:**

Charges for Unauthorized Overstay to be levied, for unauthorized stay beyond the parking slot time approved by NMIAL before the aircraft departs from the previous station in case General Aviation Aircraft (including non-scheduled operators) do not have NMIA as usual station:

1. The rates specified above are applicable to all the categories of aircraft excluding the aircraft having NMIA as usual station.
2. Charges for unauthorized overstay are inclusive of parking charges for unauthorized stay beyond the slot time allotted in case of non-scheduled aircraft not having NMIA as its usual station. Time provided by AOCC will be considered as final for billing purpose.

3. Cargo flights, non-scheduled flights operated by scheduled airlines shall be considered as scheduled flights for levying charges.
4. Charges for unauthorized overstay per hour shall be collected as follows:
  - a. Slot time allotted - normal parking charges as above
  - b. for initial 2 days (48 hours) of Unauthorised Overstay at rates proposed above.
  - c. For next 5 days (120 hours) beyond initial Unauthorised overstay of 2 days at 1.5 times of the rates proposed above
  - d. For period beyond 7 days (168 hours) or Unauthorised Overstay at 2 times or the rates proposed above.
5. Any Aircraft type not listed above will be subject to charges for Unauthorized Overstay as may be applicable to nearest equivalent MTOW of aircraft listed above.

Collection charges on User Development Fee (UDF): As per the agreement between NMIAL and the Airlines subject to a maximum of Rs. 2.50 /- (Rupees two and fifty paisa only) per Embarking or Disembarking Passenger (excluding the number of passengers exempted from paying such a charge) provided (a) NMIAL receives the invoiced UDF amount within the due date mentioned in the invoice; and (b) there are no overdue on any account with NMIAL. The collection charges so payable to the Airline will be adjusted by Credit Note during the subsequent billing cycle. However, no collection charge shall be payable by NMIAL to the airline if the airline fails to make UDF invoice payment within aforesaid applicable time limit/credit period.

2. For calculating UDF in Foreign currency, the RBI conversion rate as on the last day of the previous month for tickets issued in the first fortnight and rate as on 15th of the month for tickets issued in the second fortnight shall be adopted.
3. Exemptions in Payment of User Development Fee (UDF) - In terms of DGCA AIC No. 14/2019 dated 16.05.2019 and AIC No. 20/2019 dated 06.11.2019 (decision of Ministry of Civil Aviation, Govt. of India vide order no. AV 29012/39/2018-AD dated 30.10.2019) the following categories of persons are exempted from levy and collection of UDF:
  - a. Children (Under the age of 2 years)
  - b. Holders of Diplomatic Passport.
  - c. Airlines crew on duty including sky marshals and airline crew on board for the particular flight only (this would not include Dead Head Crew, or ground personnel),
  - d. Persons travelling on official duty on aircraft operated by Indian Armed Forces.
  - e. Persons travelling on official duty for United Nations Peace Keeping Missions.
  - f. Transit/transfer passengers (this exemption may be granted to all the passengers transiting up to 24 hours. A passenger is treated in transit only if onward travel journey is within 24 hours from arrival into airport and is part of the same ticket. In case 2 separate tickets are issued it would not be treated as transit passenger). UDF (Domestic / International) will be determined and levied based on ultimate destination in particular ticket / PNR.

### **General Conditions for all Aeronautical Tariffs:**

1. All above mentioned charges (Landing, Parking, UDF, Fuel Infrastructure Charges, ICT (CUTE/ CUSS/ BRS) Charges, X-Ray Baggage Charges, Aerobridge Charges, BME Charges, Cargo Charges etc) are exclusive of applicable taxes. Applicable taxes are payable in addition to the above charges.
2. All the charges applicable (a) to Indian Carriers (including international operations) will be in Rs. / INR; and (b) to Foreign carriers in USD.
3. **Aviation Security Fee (ASF)** shall be applicable as prescribed by Ministry of Civil Aviation from time to time.
4. Invoice for the above charges shall be raised by the Airport Operator on weekly basis and the invoice shall include applicable taxes.
5. For all the above charges, the airlines and other users of the Airport will be allowed a credit period as may be decided by NMIAL from time to time, subject to approval of credit limits by NMIAL.

6. If the invoice for any of the airport charges is not paid within the credit period, interest shall be charged at the rate of one and half percent (1.5%) per month and shall be charged on pro-rata basis for each day of delay.
7. Payment received from the airlines and other users of the Airport shall first be appropriated towards the interest due in case of overdue and unpaid invoices. Thereafter, surplus/remaining amount, if any, shall be applied towards principal dues in chronological order.
8. Flight operating under Regional Connectivity Scheme will be completely exempted from charges as per Order No.20/2016-17 dated 31.03.2017 of the Authority from the date the scheme is operationalized by the GoI or as prescribed by MoCA from time to time.

#### Terms and conditions:

1. The proposed VTP is applicable to airlines operating international routes from NMIA and that have signed a formal agreement with NMIAL to use the services provided at the Airport.
2. No discount over and above the VTP is applicable.

3. The airline operator shall operate a direct flight to an international destination.
4. VTP for passenger flight is applicable for airlines operating on international route for a minimum of 1 year. In case the airline withdraws the operations before the said period, the VTP will stand null and void.
5. The Variable International Landing Charges are applicable only for years as mentioned in the table above, from the date of the commencement of flight.
6. Passenger Flight - The payment of landing charges should be made by the airline in full without any deductions, as per the invoicing by NMIAL. The settlement shall be provided in the form of a 'Credit Note' at the end of each 1-year period. For applicable discount for subsequent years of operations, the deduction in charges shall be made in the respective year itself.
7. Freighter Flight - For applicable discount, the deduction in charges shall be made in the respective year itself.
8. NMIAL reserves the right to change any term or condition of this VTP, withdraw or replace any of the category, at any time at its absolute discretion, by way of prior notification through an appropriate channel.

General Notes:

1. All Bills shall be rounded up to the nearest higher of Rupee 1.00.
2. All minimum charges shall be rounded off to the nearest higher of Rupee 1.00.
3. All applicable taxes, including Goods and Services Tax, shall be payable over and above the above charges at the prevailing rates from time to time.
