
Sub: Empanelment of Consulting Agencies to assist AERA in Determination of Tariff and for conduct of Strategic & Economic Studies – Extension of validity of empanelment reg.

The Authority vide EoI No. 04/ 2019-20, empanelled agencies to assist AERA in determination of Aeronautical Tariff and for conduct of Strategic & Economic Studies viz., under two categories, namely, Category "A" (Major Airports having annual passenger throughput of 10MPPA and above) and Category "B" (Major Airports having annual passenger throughput less than 10MPPA).

1.2 In this regard, Public Notice No. 04/2020-21 dated 01.06.2020, corrigendum dated 29.06.2020 and corrigendum II dated 03.01.2024 have been issued, inter-alia, mentioning the category wise empanelled agencies for the subject work (copies enclosed).

2. The validity of the Empanelment of Consulting Agencies to assist AERA in determination of tariff and for conduct of strategic and economic studies is valid till 31.05.2025. With approval of the competent authority, the validity of the said empanelment is extended for a period of six months beyond 31.05.2025 i.e., till 30.11.2025.

3. All other terms and conditions of the empanelment shall remain same.

The validity of above panel shall be for five years, however the Authority reserves the right at its discretion to update the panel **every year** and AERA may add / delete any agency based on documents received towards stipulated eligibility criteria/performance of the consultancy services. AERA may also remove any agency from the Panel if it concludes that they have not demonstrated adequate capability of providing the required services in a professional manner or the quality of service is found to be inadequate after the award of contract.
2. Mere empanelment with AERA does not guarantee assignment of work to any of the empanelled agencies.
3. AERA reserves the right to invite techno commercial bids from empanelled agencies and evaluate the same based on QCBS, CBS or any other evaluation model as deemed fit for award of contract or may assign any project or study to the agency on nomination basis.

4. AERA will be at liberty to call open tenders, if desired, for any works/assignment and the Empanelled Agencies shall have no objection to this even if the work is for that category (i.e. 'A', 'B') for similar type of works. AERA further reserves the right to modify the evaluation criteria and take its own decision, if so required.
5. AERA reserves the right at its discretion to delist Empanelled agencies, who do not participate in consecutive 3 (Three) bids invited by AERA after empanelment.
6. AERA reserves the right at its discretion to assign any study to an independent professional or any premier academic institution.
7. AERA also reserves the right at its discretion to cancel this empanelment at any time without assigning any reason thereof.

Corrigendum to Public Notice No. 04/2020-21 dated 01.06.2020.

Sub: Empanelment of Consulting Agencies to assist AERA in Determination of Tariff and for conduct of Strategic & Economic Studies.

1. The Authority vide Public Notice. No. 04/2020-21 dated 01.06.2020 has empanelled M/s Deloitte Touche Tohmastu India LLP and M/s Ernst & Young LLP under Category “B” to assist AERA in Determination of Tariff and for conduct of Strategic & Economic Studies.
2. Subsequent to the issue of Public Notice. No. 04/2020-21, M/s Deloitte and M/s E & Y has represented that they have applied for Category “A” empanelment and if get selected, they shall automatically qualify for Category “B” also.


