
Subject: - Consultation Paper No. 14/2013-14 dated 26.06.2013 regarding determination of Aeronautical Tariffs in respect of Bengaluru International Airport, Bengaluru for the first control period (01.04.2011 - 31.03.2016) – extension of time - reg

Attention of all concerned is invited to Consultation Paper No. 14/2013-14 dated 26.06.2013, issued by the Authority in the matter of "Determination of Aeronautical Tariffs in respect of Bengaluru International Airport, Bengaluru for the first control period (01.04.2011 - 31.03.2016)" and subsequent Public Notice No. 4/2013-14 dated 02.08.2013 vide which the last date of submission of comments was extended upto 19.08.2013. Thereafter, requests were received from Government of Karnataka, Ministry of Civil Aviation (MoCA), and Association of Private Airport Operators requesting for further extension of time to furnish their views on the said Consultation Paper dated 26.06.2013. Based on their request the last date of submission of comments was extended upto 19.09.2013 vide Public Notice No. 6/2013-14 dated 19.08.2013.

2. MoCA, vide its letter no AV.20036/19/2013-AD dated 16.09.2013 (**Annexure I**) has requested for further extension of time upto 01.11.2013 for furnishing comments on the said consultation paper. The MoCA has stated that "*Ministry of Civil Aviation is in the process of examination of the consultation paper no. 14/2013-14 dated 26.06.2013 issued by AERA which will take some more time.*" In the meantime, however, comments of MoCA on the Consultation Paper No.14/2013-14 dated 26.06.2013 have since been received.

3. Having regard to the above and considering the request of MoCA and the fact that comments from the MoCA have since been received, the Authority has decided to extend last date of submission of comments upto 25.09.2013.

4. Further as already indicated in the Public Notice No. 6/2013-14 dated 19.8.2013, M/s Bangalore International Airport Private Limited has also made fresh submissions under hybrid till which are being separately examined by the Authority. The Authority will issue a fresh consultation paper in this regard in due course for stakeholder consultation.
