Subject:- Consultation Paper No. 05/2014-15 dated 12.06.2014 in the matter of Normative Approach to Building Blocks in Economic Regulation of Major Airports - reg.

Attention of all concerned is invited to Consultation Paper No. 05/2014-15 dated 12.06.2014, issued by the Authority in the matter of Normative Approach to Building Blocks in Economic Regulation of Major Airports vide which the Authority had sought comments from the stakeholders. The last date of submission of comments initially stipulated was 07.07.2014. This was subsequently extended to 08.09.2014. Thereafter it was further extended to 09.10.2014 and further upto 07.11.2014 based on request received from APAO, Airport Operators and other stakeholders.

2. APAO has once again, vide letter no. APAO/AERA/2014-15 dated 04.11.2014 informed the Authority that their consultant after collecting international data on some very important and critical issues of the consultation paper has provided them an elaborate draft report of the consultation paper, which is now being thoroughly, examined and deliberated amongst their member Airports. This being a very important consultation paper having far reaching repercussions and impact on the investments made, a thorough and extensive study is required to be done collectively by all their member Airports on the draft report prepared by their consultant.

3. APAO has therefore requested the Authority to provide APAO and its members an additional 45 days time (i.e. upto 22.12.2014) to enable them to take firm view on the various issues raised in the aforesaid consultation paper. Similarly, Confederation of Indian Industry (CII), vide e-mail dated 05.11.2014 has sought time upto 31.12.2014 for submitting their response. DIAL and HIAL vide letters dated 05.11.2014 have also requested to extend the date upto 31.12.2014. BIAL and MIAL vide letters dated 05.11.2014 have requested for extending the date by one month. (collectively at **Annexure – I**).

4. The request made by the above stakeholders was considered by the Authority and in view of the specific request for extension, it was decided that the last date for submission of comments on Consultation Paper No. 05/2014-15 dated 12.06.2014 be further extended up to **08.12.2014**.


