

Reference : Consultation Paper (CP) No. 19/2018-19 dated 9th October 2018.
Subject : Tariff Proposal for Ground Handling Services at Bengaluru.

We would like to bring your kind attention on the following para of above referred CP;

Para 3.4 – Proposed increase in price by 5% in FY2020-21 over FY2018-19 i.e. after two years means annual increase is about 2.50%, which is a very reasonable and less than average inflation. Hence, we once again request Authority to reexamine this and approve this price increase proposal.

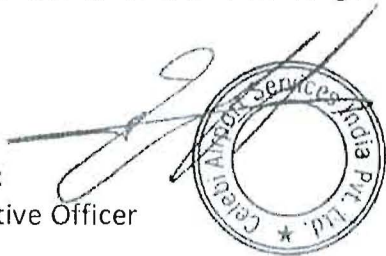
Para 3.5 – We respect Authority view of discrimination in price for Indian carriers and International carriers, however prices proposed by Authority in Annexure – II needs to be replaced with the below price table. Also like to highlight that this revised price is about 50% below competitor's price.
