**Amendment to Public Notice 17/2019-20**

**Sub.: Major Airports under clause (i) of Section 2 of the AERA Act, 2008.**

The following is in partial modification of the earlier Public Notice on the subject.

As per the provision of clause (i) of Section 2 of the Airports Economic Regulatory Authority of India Act 2008, as amended by AERA (Amendment) Act 2019 or as notified by Ministry of Civil Aviation under the said provision, the following airports are considered as “major airports” as on 28.02.2020.

Kannur International Airport Limited (KIAL), Kannur is declared as ‘Major Airport’ based on their certified built-up capacity of 9.34 mppa with built-up terminal area of 96143 sqm.

Further, as per the clarification of MoCA vide letter no. AV.20036/9/2017-AD dated 14.01.2020, the tariff as already determined by AERA for Indore, Srinagar, Coimbatore, Vishakhapatnam and Nagpur Airports, shall continue to be applicable for the current Control Period even though those are not ‘major airports’ under the amended AERA Act.. Once the current Control Period is over, the tariff determination shall take place based on the passenger throughput criteria as amended in AERA Act.
