Subject: Multi Year Tariff Proposal (MYTP) with respect to Lucknow Airport.

Sir,

This has reference to the discussions between the undersigned and the Chairman, Members and Secretary, AERA on 9th July, 2014 in the office of AERA.

As discussed, the following corrections/modifications are made in our MYTP with respect to Lucknow Airport:

- 1. The total amount apportioned to Lucknow Airport in the year 2011-12 has been modified from Rs. 27.29 crores to Rs. 24.93 crores (Annexure - A). Accordingly, the total amount of apportionment to Lucknow airport for the entire control period has been brought down from Rs. 129.53 crores to Rs. 116.48 crores (Annexure - B).
- 2. As per MYTP with respect to Lucknow Airport submitted to AERA, UDF was proposed at the rate of Rs.480/- per embarking passenger (domestic) and Rs.1000/- per embarking passenger (International) for the year 2013-14 with an annual increase of 6% p.a. Accordingly, UDF for the year 2014-15 worked out to Rs.509/- per embarking passenger (domestic) and Rs.1060/- per embarking passenger (International) and for the year 2015-16 Rs.540/- per embarking passenger (domestic) and Rs.1124/- per embarking passenger (International).

After the discussions on the AERA's proposals at para 21 of the Consultation Paper No. 01/2014-15 for reducing the UDF, and considering the UDF at similar airports, it is agreed to reduce the burden on the domestic passengers embarking from Lucknow Airport. Thus, domestic UDF may be determined at Rs.370/- (Rs350/- for the year 2013-14 + 6% annual increase) per embarking passenger (domestic) for the year 2014-15 and Rs. 392/- (Rs. 370/- + 6% annual increase) for the year 2015-16. The resultant increase in the under recovery shall be carried forward at the time of determination of ARR for the next control period.

It is requested to make the above corrections in our proposal and issue the tariff order at the earliest.

This has the approval of the competent authority.
