Sub: Multi Year Tariff Proposal for First Control Period submitted by Bharat Stars Service Private Limited for Into Plane Service fee at IGI Airport, Delhi

Reference may kindly be made to Consultation Paper 03/2011-12 dated 28th April, 2011 on the subject. Our comments are as under:

i) We agree to the proposal for regulating the services of BSSPL at terminal T-3, IGI Airport Delhi, under light touch approach during the first control period

ii) The tariff proposed for the period 28.07.2010 to 31.03.2011, for various fuelling/defueling services was provided by BSSPL to the Suppliers at the time of execution of the ITP agreement during July, 2010 and the same has been considered for recoveries. However, the tariff proposed for the period 1.04.2011 to 31.03.2012 has been arrived at after escalating the previous year tariff by 5%.

Vide our earlier letter ref. AV/RS/AERA dated 23rd March, 2011, we had requested AERA iii) that approval of tariffs/ rates/ including fuel throughput charges for the first control period may please be finalised at the earliest possible and revisions if any, may be made from prospective date.

In view of the above, it is suggested that AERA may approve the tariffs. as proposed under clause 5.2 of the Consultation Paper 03/2011-12, as under:

- ITP rates as mentioned for the period 28.07.2010 till 31.03.2011. a)
- b) Continuation of the above ITP rates beyond 31.03.2011 till the last day of the month in which AERA issues the order.
- c) ITP rates as mentioned for the first control period (2011-12). However, the same may be made effective on prospective basis, from the first day of the subsequent month, in which AERA issues the order.
