Sub: Comments on Consultation Paper no. 41/2012-13 dated 6th March, 2013 - Annual Tariff Proposal submitted by Bharat Stars Services Private Limited for providing Into Plane Services at IGI Airport, New Delhi.

Dear Madam,

This has reference to Consultation Paper no. 41/2012-13 on the subject. Our comments on the proposal contained at para 7 of the Consultation Paper are as under:

- The tariff proposed for the period 1.04.2013 31.03.2014, 1.04.2014 31.03.2015 and i) 1.04.2015 - 31.03.2016 for various fuelling/ defueling services has been arrived at after escalating the tariff existing as on 31.03.2013 by 5%.
- As per concession agreement signed between BSSPL and DIAL, the tariff shall be ii) escalated at a rate of 5% or WPI each year, whichever is lower. It is noted that with the proposed 5% increase of tariff every year, the Authority has assumed a WPI of 5% or lower for all these years. In case the WPI for any subsequent year is lesser than 5%, the escalation may have to be lower than 5%.

Since the proposed tariff for third tariff year (1.04.2013 to 31.03.2014) is more than the existing tariff, it is requested that AERA may please issue the necessary order before 1.04.2013 in order to enable the Suppliers to recover the same from 1.04.2013. In case the order is expected to be issued after 1.04.2013, it is requested that the order may please be issued on prospective basis.
