The Government of India in the Ministry of Civil Aviation has constituted the Selection Committee for the purpose of selecting Secretary, Airports Economic Regulatory Authority under Airports Economic Regulatory Authority of India (Secretary), Recruitment Rules, 2012.

2. Applications are hereby invited for consideration of the Selection Committee for selection of Secretary of the AERA in the Pay Band of Rs. 37,400-67,000/- (PB-4 with a Grade Pay of Rs.10000), from officers under the Central Government:-
