In the matter of Annual Tariff Proposal submitted by M/s Menzies Bobba Ground Handling Services Pvt. Ltd for Third Tariff Year (2013-14) of the first control for providing Ground Handling Services at Rajiv Gandhi International Airport, Shamshabad, Hyderabad.

The Authority had, vide its Order No. 25/2011-12 dated 13.11.2011, ordered that it shall adopt a "light touch approach" for determination of tariffs for the first Control Period w.e.f. 01.04.2011 for the Ground Handling Services provided by M/s Menzies Bobba Ground Handling Services Pvt. Ltd. (Menzies) at Rajiv Gandhi International Airport, Shamshabad, Hyderabad. Subsequently, the Authority also determined the tariff for first and second tariff years of the current control period vide Annual Tariff Order No. 15/2012-13 dated 11.09.2012.

- 2. Thereafter, Menzies, vide its letter no. Nil dated 22.02.2013, submitted the Annual Tariff Proposal (ATP) for the third tariff year (01.04.2013 31.03.2014).
- 3. The Authority considered these submissions made by Menzies and issued Consultation Paper No. 2/2013-14 on 04.04.2013.
- 4. No comments have been received from the stakeholders in response to the proposal contained in the Consultation Paper No.02/2013-14 dated 04.04.2013.

ORDER

5. Upon careful consideration of material available on record, the Authority, in exercise of powers conferred by Section 13(1)(a)of the Airport Economic Regulatory Authority of India Act, 2008, hereby orders that:



- (i) The Tariffs for the third year(2013-14) of the First Control period for ground handling services provided by M/s Menzies Bobba Ground Handling Services Pvt. Ltd at Rajiv Gandhi International Airport, Shamshabad, Hyderabad is determined as at **Annexure-I.**
- (ii) These tariffs will be the maximum tariffs and will be effective from 01.04.2013.
